Minutes State Board of Education Meeting February 3, 2016 (approved March 2, 2016)

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, February 3, 2016, in Room 307 of the State Office Building, 165 Capitol Avenue, Hartford, Connecticut.

I. Call to Order

Dr. Torres discussed that CTHSS has (i) partnered with business and industry to develop career and technical education programs for regional needs; (ii) aligned its curriculum program and workers to be responsive Connecticut's employers and job projections; and (iii) partnered with community colleges to train and develop adults.

G. State Student Advisory Council on Education

Members of the State Student Advisory Council on Education (SSACE) presented an outline of the SSACE three areas of focus in the 2015-16 school year. Timothy J. Noel-Sullivan, a senior at Classical Magnet in Hartford, and Susannah M. Beyl, a student at West Haven High School, reported that the three areas under review by SSACE for 2015-16 are (1) Health and Wellness Reform (social, emotional and physical health); (2) 12th Grade Experience, and (3) Equity. SSACE students will review the 2016-17 student applications for membership on the State Board of Education in 2016-17 and recommend five students to the Governor for his consideration.
