Minutes State Board of Education Meeting April 6, 2016

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, April 6, 2016, in Room 307 of the State Office Building, 165 Capitol Avenue, Hartford, Connecticut.

I. Call to Order

Chairperson Allan Taylor called the meeting to order at 9:42 a.m.

II. Public Participation

- Dr. Michael P. Alfano, Dean, School of Education and Professional Studies, Central Connecticut State University, spoke in support of agenda item V.D., New Program Approval (MAT Content Programs: History/Social Studies and Special Education), Central Connecticut State University. A copy of Dr. Alfano's prepared remarks is enclosed in the official file of this meeting.
- 2. Patrice McCarthy, Deputy Director and General Counsel, Connecticut Association of Boards of Education, and member of the Performance Evaluation Advisory Committee (PEAC), spoke in support the Board's approval of agenda item V.B., Adoption of PEAC Recommendations, to amend the PEAC Guidelines (i.e., allow local educational agencies to continue with implementation of their current CSDE-approved plan for the 2016-17

- school year; and continued flexibility with respect to the incorporation of state test data in the evaluation of educators through the 2016-17 school year).
- 3. Tom Stringfellow, resident of Manchester, recommended several articles, books and movies describing the role of African Americans throughout history. He also spoke about gun violence, the value of multilingualism, Earth Day, and special education.
- 4. Matthew Borrelli, former teacher and school administrator, addressed the Board about how to change systems to improve the education for children. Mr. Borrelli read prepared remarks about the importance of supervising educators; what test scores measure; and the misuse of race and the impact of poverty on learning. A copy of Mr. Borrelli's prepared remarks is enclosed in the official file of this meeting.
- 5. Jennifer Alexander, Chief Executive Officer of ConnCAN, expressed concerns about PEAC's proposal to delay the incorporation of student achievement growth in educator evaluations. Ms. Alexander stated that this is an important part of a balanced approach to evaluation, and urged the Board to ensure that this link is ultimately made. A copy of Ms. Alexander's prepared remarks is enclosed in the official file of this meeting.
- 6. Ann Marie Mulready, Ph.D., Connecticut Association for Reading Research (CARR), expressed CARR's concerns about the elimination of the English Language Arts Performance Task from the Smarter Balanced Assessment. A copy of Dr. Mulready's prepared remarks is enclosed in the official file of this meeting.
- 7. Jeffrey Villar, Executive Director of the Connecticut Council for Educator Reform, spoke about the PEAC recommendations to the State Board of Education (agenda item V.B.). Mr. Villar acknowledged Connecticut's achievement gap, the college and career readiness rate, and the related costs to Connecticut. He stated that the SBAC assessment provides for consistency across the state and allows for the elimination of redundant assessments. He stressed the importance of sending a message to all educators regarding their responsibility for student learning, without regard to race or economic background.
- 8. Janet L. Steinmayer, President of Mitchell College, expressed her support for agenda item V.C., Continuing Program Approval, Mitchell College. She described Mitchell College's support for improvement in its early childhood education, which prepares undergraduate students for certification in nursery through grade three. A copy of Ms. Steinmayer's prepared remarks is enclosed in the official file of this meeting.
- 9. Attorney Dennis O'Brien, representing the town of Chaplin, urged the Board to consider his written request for a partial waiver of the proposed 2015-16 minimum budget requirement penalty at the Board's earliest convenience.
- 10. Sylvia Henderson, a resident of Windsor, vice president of Parents Advancing Change in Education, and a member of the clergy in Windsor, expressed her concerns about Windsor's move from differentiated instruction to leveled instruction for purposes of cost

containment. Ms. Henderson stated that the Windsor Board of Education needs to receive information about the value of differentiated instruction in order to make informed decisions.

- 11. Dr. James C. Carl, Dean, Farrington College of Education, Sacred Heart University, spoke in support of agenda item V.E., New Program Approval: Sacred Heart University, Speech and Language Pathology Program. Dean Carl also stated that additional time is needed to finalize Sacred Heart's master degree requirements to meet the state requirement of a master's degree in an appropriate subject matter area to maintain certification. A copy of Dr. Carl's prepared remarks is enclosed in the official file of this meeting.
- 12. Michael Galluzzo, Connecticut Association of Schools, spoke in support of the PEAC process and the recommendations contained in the resolution before the State Board of Education today (agenda item V.B.). Mr. Galluzzo stated his opposition to Senate Bill 380, noting that student growth is an appropriate measure across the board for all students.
- 13. Lenny Speiller, Vice President of Communications and External Relations, Achievement First, was unable to attend the meeting but submitted written testimony in support of agenda item V.A., Approval of Material Changes to Elm City College Preparatory School. A copy of Mr. Speiller's written statement is enclosed in the official file of this meeting.

memorandum to the State Board of Education, and directs the Commissioner to take the necessary action.

G. Waiver of Repayment of Special Education Excess Cost Grant Pursuant to Section 10-76g: Winchester

WHEREAS, The Town of Winchester, pursuant to Section 304(b) of Public Act 15-5 of the June Special Session, has applied for a waiver of the first of five repayments of \$144,173 required to be made annually by April 30th under Section 304(a) of Public Act 15-5 of the June Special Session for reimbursement of overpayments

made by the State pursuant to Section 10-76g of the General Statutes during the fiscal years ending June 30, 2013, to June 30, 2014, inclusive; and

WHEREAS, the Town of Winchester has demonstrated significant improvement in the fiscal and financial practices of its school district, has demonstrated that structural changes have been implemented to ensure the school district is properly handling taxpayer funds, and has satisfied other criteria required by the Commissioner; now therefore be it,

RESOLVED, That the State Board of Education approves the waiver application submitted by the Town pursuant to Section 304(b) of Public Act 15-5 of the June Special Session for the payment to be made by April 30, 2016, and directs the Commissioner to take the necessary action.

Haberlandt provided an update on the Connecticut State Department of Education Investigation into the November 2015 District Training Exercise at SAND Elementary School in Hartford. E. Connecticut Technical High School System (CTHSS) Board

Mr. Trefry reported that today CTHSS has a display in the Judiciary Room of the State Capitol. Mr. Trefry referenced \$4 million in rescissions, a decline in fuel costs, and priority positions in the CTHSS. The Skills USA Competition was held this week. Mr. Trefry announced that the National Automotive Competition was held in New York City. Two students from Norwalk Technical High School won the competition.
