Minutes State Board of Education Meeting June 1, 2016 (approved July 6, 2016)

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, June 1, 2016, in Room 1D of the Legislative Office Building, 300 Capitol Avenue, Hartford, Connecticut.

I. Call to Order

Chairperson Allan Taylor called the meeting to order at 9:45 a.m.

II. Public Participation

- 1. Ms. S. Hudson, resident of Hartford, expressed her concerns about the lottery selection process for public school choice schools, noting that the process does not provide equitable access to applicants.
- 2. Ms. Hyacinth Yennie, parent and advocate, expressed her concerns that the intent of Sheff v. O'Neill is not being fulfilled, noting that greater segregation exists now. She stated that we need to invest more within the community, particularly for Hartford's neighborhood schools.
- 3. Dr. Aaron Lewis, parent and child advocate, spoke about the need for enhanced accountability measures to ensure that students are safe, and that investigations take place when staffing issues are suspected, to avoid potential danger to students.

Mr. Vrabely moved, Ms. Sieve seconded, to amend the resolution and pertinent information contained in the June 1, 2016, memorandum referenced therein, by excluding Achievement First Hartford Academy (AFHA) from those schools being granted an enrollment waiver in 2016-17; adjusting the total enrollment from 9,572 to 9,567 to reflect the deletion of the five additional seats requested by AFHA; and changing the number of enrollment waivers from seven to six.
