Minutes State Board of Education Meeting May 3, 2017

(Approved June 14, 2017)

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, May 3, 2017, in Plaza North Room C and D of the State Office Building, 450 Columbus Boulevard, Hartford, Connecticut.

I. Call to Order

Chairperson Allan Taylor called the meeting to order at 9:45 a.m.

II. Public Participation

1. Theresa Mieczkowski, parent of children in Regional School District No. 14, requested the Board's support in ensuring that her son receives the necessary educational services and supports. She explained that her son, who has a medical condition and qualifies under Section 504, was bullied at school and, consequently, requires home instruction. Her son did not receive an Individualized Education Plan (IEP), and did not receive instruction for an extended period of time. Ms. Mieczkowski expressed her concerns and frustration about not being successful in her attempts to ensure that her son receives the requisite services at the local school district, state and federal levels. She noted that the Office of Civil Rights and the Commission on Human Rights and Opportunities have

not been of assistance, and the State Department of Education informed her that they are unable to assist her since her son does not have an IEP. As a result, her son, who was an honor student, must now repeat the ninth grade and the parents will need to pay for tuition next year.

Commissioner Wentzell stated she was sorry to hear of their experience, and would ensure that Dr. Adrian Wood, Education Consultant, would provide the appropriate guidance to Mrs. Mieczkowski.

- 2. Bernard Thomas, Executive Director, Hartford Knights Youth Organization, stated his concerns about students in the Hartford area not receiving proper services and support while suspended from school. Mr. Thomas emphasized that students need additional services to help keep them on the right track. He also stated that many students who are released from detention facilities are not enrolled in school in a timely manner, due to delays in transferring school records.
- 3. Gwen Samuel, CT Parents Union, stated that the State Board of Education is the ultimate body to ensure the safety and well-being of all children; it has the legal authority to hold accountable those districts that are not complying with the law regarding suspensions and expulsions. She highlighted the disproportionate impact this has on black and brown children. Ms. Samuel noted the Johns Hopkins University Study regarding the positive impact of having one black teacher on a student's success. She stated that the Board's goal of reaching a 10% threshold for minority teachers over the next five years was not rigorous. Ms. Samuel then reminded the Board not to lose sight of the recent report released by the Office of the Child Advocate.
- 4. Tom Stringfellow, resident of Manchester, recommended several publications and documentaries on historical and events and role models. A copy of Mr. Stringfellow's statement is included in the official file of this meeting.
- 5. Donald Black, parent of a former student and a current student attending Jumoke Academy, expressed his support for the recommendation to renew the school's charter. He described the positive impact the school has had on his children and commended the committed teachers at Jumoke.

III. Executive Session

The Board did not meet in executive session.

X. Items for Discussion

The Board unanimously agreed to consider agenda item X.A., Report on Student Discipline, at this time.

A. Report on Student Discipline

A panel consisting of Chief Operating Officer Charlene Russell-Tucker, Bureau Chief John Frassinelli, Meriden School Superintendent Mark Benigni, and Emily Morgan, Council of State Government Justice Center, presented a PowerPoint presentation on school suspensions and expulsions data in Connecticut and on the national level. Discussion ensued.
