Minutes State Board of Education Meeting June 14, 2017 (Approved July 19, 2017)

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, June 14, 2017, in Plaza North Room C and D of the State Office Building, 450 Columbus Boulevard, Hartford, Connecticut.

I. Call to Order

II. Public Participation

- Dr. Richard Kisiel, Connecticut Association of Public School Superintendents (CAPPS), in support of agenda, item, IX.E., Adoption of Resolution in Support of Mastery-based Personalized Learning. Dr. Kisiel stated that there are 29 districts implementing mastery-based personalized learning on varying school levels. Dr. Kisiel acknowledged the leadership of the Board and community to continue to work collaboratively.
- Robert Rader, Executive Director, Connecticut Association of Boards of Education, in support of agenda item, X.A., Guidance on Civil Rights Protections and Supports for Transgender Students. - 3. Tom Stringfellow, resident of Manchester, thanked the two student members for their one-year service on the Board. Mr. Stringfellow recommended several publications and documentaries on historical events: Battle of Midway, the USS Liberty, "The Great War" American Experience documentary, and an article on Irene Morgan Kirkaldy. Mr. Stringfellow recommended the book, "Thinking Differently: An Inspiring Guide for Parents of Children with Learning Disabilities," by David Flink. - 4. Rebecca Holcombe, Director of Community Programs, Common Ground, New Haven. Ms. Holcombe spoke on the Nature Year program. Nature Year is a partnership program where students spend one day a week throughout the school year engaged in a nature program that is based on science. Common Ground is seeking support from the State Board of Education for parents who are concerned that the district views nature day participation as an absence.

A. Guidance on Civil Rights Protections and Supports for Transgender Students

Legal Director Peter Haberlandt presented to the Board the Connecticut State Department of Education's *Guidance on Civil Rights Protections and Supports for Transgender Students* for Connecticut school districts on the rights of gender minority students. Connecticut schools have a legal obligation to provide an equal educational opportunity for all students, including gender minority students. The guidance document was designed to assist schools and districts in implementing civil rights protections for transgender students under state and federal laws. The guidance will be disseminated to Connecticut school districts on the legal obligations, rights, responsibilities and best educational practices for ensuring equal treatment of transgender students.
