# Minutes State Board of Education Meeting June 6, 2018

(Approved September 5, 2018)

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, June 6, 2018, in Plaza North Meeting Room C and D of the State Office Building, 450 Columbus Boulevard, Hartford, Connecticut.

## I. Call to Order

# <u>Connecticut Teacher of the Year Recognition 2018 – Erin Berthold</u>

Commissioner Dianna Wentzell recognized the Connecticut State Teacher of the Year 2018 - Erin Berthold. Ms. Berthold currently teaches first grade at Cook Hill School in Wallingford, under the leadership of Superintendent Dr. Salvatore F. Menzo and Principal Kristine Friend.

The Commissioner thanked the Talent Office under the direction of Chief Talent Officer Dr. Sarah Barzee, and Kim Wachtelhausen, Connecticut Teacher of the Year Program Coordinator. Dr. Barzee thanked the Commissioner and the State Board of Education for support of the Teacher of the Year Program, as well as Ms. Wachtelhausen for her demonstrated passion as coordinator and liaison. Dr. Barzee referenced that Connecticut has received recognition from the National Network of State Teachers of the Year (NNSTOY) for having a strong program.

Ms. Wachtelhausen spoke on the rigorous process, the support of the State Department of Education and the Connecticut Teacher of the Year Council, sponsorships, professional learning opportunities for finalist and semifinalists, and introduced Ms. Berthold.

Ms. Berthold spoke on intentionally wanting to teach in Connecticut, and the incredible year of learning she has been experiencing, and hopes to share the knowledge with the district.

# II. Public Participation

- 1. Gino LoRicco, Principal of Path Academy, Windham, spoke concerning the changes that Path Academy has experienced since March 21, 2018.
- 2. Deborah Callahan, Special Education Teacher, Path Academy, Windham, spoke in support of Path Academy.
- 3. George Hernández, Board Chairperson, Windham Charter School Corporation, spoke in support of Path Academy.
- 4. Michael Wetherell, State President of the Connecticut FFA Association, presented Commissioner Wentzell with a FFA Leadership Award from the Connecticut FFA Association and recognized her as a true leader and role model for students across Connecticut.
- 5. Aram Ayalon, Professor of Education, Central Connecticut State University and former board member of New Britain Public Schools, spoke on reducing the achievement gap and promoting bilingual education.
- 6. Angela Lopez-Velasquez, Associate Professor, Southern Connecticut State University, spoke on the English Language Learners population, teacher shortage areas, the teacher shortage for ESL and bilingual, and the obstacle of cross endorsements.
  - Commissioner Wentzell followed up and thanked Ms. Lopez-Velasquez for her advocacy in this area. The Commissioner stated that Governor Malloy signed An Act Concerning Minority Recruitment, which includes a provision on cross-endorsements and shortage areas. Commissioner Wentzell requested that Ms. Lopez-Velasquez share her contact information with Dr. Sarah Barzee.
- 7. Dr. Elizabeth Howard, Associate Professor, Bilingual Education, University of Connecticut, Neag School of Education, University of Connecticut and the chair of Higher Education Advocates for Language Learners (HEALL), spoke on English language learners and dual language education. A copy of Dr. Howard's written statement is enclosed in the official file of this meeting.
- 8. Melissa Hamel, a parent, shared her concerns regarding her daughter who attends Thomaston Center School, Thomaston.
- 9. Jalysa Smith, a student at Thomaston Center School, Thomaston, spoke about her experiences at school.

Commissioner Wentzell followed up and requested that Melissa Hamel and Jalysa Smith immediately meet with a member of her senior staff to discuss their specific concerns.

10. Brooke Miron, a parent of the Stratford public school student, expressed concerns regarding Stratford board of education's vote to de-magnetize Stratford Academy. A copy of Ms. Miron's written statement and petition are enclosed in the official file of this meeting.

Commissioner Wentzell followed up with Ms. Miron. The Commissioner explained that the State Department of Education did not have direct authority over local magnet schools and requested that a senior staff member of Regional School Choice Office meet with Ms. Miron to provide her with information.

- 11. Michelle Back, Assistant Professor, Neag School of Education, University of Connecticut, spoke in support of agenda item IX.G., Approval of New Educator Preparation Program: University of Connecticut, Mandarin Chinese Program.
- 12. Dr. Salvatore Pascarella, Superintendent, Danbury Public Schools, spoke in support of agenda item V.E., 180-Day School Year Waiver Request Danbury Public Schools.
- 13. Thomas Stringfellow, resident of Manchester, addressed the Board on several matters.
- 14. Orlando Rodriguez, Research and Policy Development Specialist and Chief Economist, Connecticut Education Association (CEA), spoke in opposition to agenda item V.B., Approval of Charter Management Organization Contract, Stamford Academy. A copy of Mr. Rodriguez's written statement is enclosed in the official file of this meeting.
- 15. Gwen Samuel, Founder and President of CT Parent's Union, spoke about an incident that occurred at her daughter's school, and the need to have proper directives in place to guide school roles and responsibilities.
- 16. State Student Advisory Council on Education End-of-Year Presentation

Commissioner Wentzell introduced the partnership in public education of David Maloney, Assistant Executive Director, Connecticut Association of Schools and his leadership of the State Student Advisory Council on Education (SSACE). Mr. Maloney provided a brief history of SSACE and introduced the students who would be presenting SSACE's end-of-year report to the State Board of Education. For 2017-18, SSACE focused its attention on: (i) Summer Slide Committee; (ii) Connecticut Breakfast Program; Summer Slide Committee; (iii) Careers in Education; and (iv) SSACE Projects.

(1) <u>Summer Slide Committee</u> was presented by: **Isabella Secchiaroli** – Academy of Our Lady of Mercy-Lauralton Hall:

**Goal**: To prevent the summer slide by continuing learning over the summer through hands-on experiences and eliminating the negative connotation of summer school.

(2) <u>Connecticut Breakfast Program</u> was presented by: **Abigail Leander** – Plainville High School:

**Goal**: To help make breakfast more obtainable for students across Connecticut.

(3) <u>Careers in Education</u> was presented by: **Tamashi Hettiarachchi** – Glastonbury High School:

**Goal**: To increase student interest in pursuing a career in education by changing the public perception of teaching.

A video was presented of an elementary school teacher who had a unique individualized handshake greeting for each of his students.

(4) <u>SSACE Projects</u> were presented by: (i) **Ananya Kachru** – Amity Regional High School, and (ii) **Zaviana Desarmes** – Windsor High School:

Such authorization is contingent upon Hayestown Elementary, Pembroke Elementary, and Broadview Middle having at least 182 school days for the 2018-19 school year and the remaining schools 181 days. # VI. Report of the Chair

- <u>Talent Office</u>. This is a program to engage and encourage veterans to choose a career in education and help facilitate the preparation and placement of veterans in priority certification shortage areas.
- <u>Charlene Russell-Tucker</u>. Kudos to Chief Operating Officer Charlene Russell-Tucker on being honored as a *Champion* by the Campaign for Grade-Level Reading's at its GLR Week 2018 conference, as well as an award for *Partners for Health Change* at the New Haven Public Schools Fourth Annual Health and Wellness Summit.
- <u>Ellen Cohn, Deputy Commissioner</u>. Congratulations to Deputy Commissioner Ellen Cohn for being honored at the Second Annual Connecticut Association of Latino Administrators and Superintendents (CALAS) Gala with the *Policy Change Award*. Deputy Cohn advocated for accommodations for English Learners for College Board assessments.
- Meriden Project Excel Top Scholar's Banquet. The Commissioner Wentzell attended the Meriden Project Excel Top Scholar's Banquet with Board Member Erin Benham. The Commissioner appreciated that the students honored were able to invite a person who was influential to them from elementary, middle and high school.
