matter, the State Board of Education hereby having found that the City of Ansonia may be responsible for the failure or inability of the Ansonia Board of Education to implement the educational interests of the state; and the State Board of Education further directs the Commissioner to provide notice of this complaint to the City and BOE by providing them a copy of the Section 10-4b Complaint attached to the Commissioner's September 5, 2018 report to the State Board of Education and to take all other necessary action.

X. Items for Discussion

A. Update: Juvenile Justice Policy and Oversight Committee (JJPOC)

Chief Operating Officer Charlene Russell-Tucker and Bureau Chief John Frassinelli provided an update on the progress made by the Juvenile Justice Policy and Oversight Committee (JJPOC) to reform the Connecticut juvenile justice system and provide supports for youth diverted from or involved with the juvenile justice system. The work of the JJPOC has been largely conducted through its four work groups: Diversion, Incarceration, Recidivism, and Cross Agency Data Sharing.

B. Update on Students Displaced by Disasters

Chief Operating Officer Charlene Russell-Tucker and Education Consultant Louis Tallarita (McKinney-Vento State Coordinator) provided an update on the Connecticut State Department of Education's (CSDE) efforts and outcomes related to students displaced by the storm-related events in Puerto Rico, the U.S. Virgin Islands, Florida, Texas and other affected areas. The CSDE collaborated with local education agencies (LEAs) to ensure immediate school access, school stability and academic success for all students displaced by disasters, including all students experiencing homelessness as defined under the McKinney-Vento Homeless Assistance Act.

C. Finance, Audit, and Budget

D. Legislation and Policy Development

Mr. Vrabely reported that Chief Talent Officer Sarah Barzee and Dr. Katie Moirs provided two presentations: (i) ACES Alternate Route to Certification for Library Media Specialist (AARCLMS) Program (State Continuing Approval), which was on the consent agenda, and (ii) Relay Alternate Route to Certification (ARC) (State Continuing Approval), which will be sent to the Board in October. The Committee commenced an ongoing discussion regarding Public School Choice.

E. Connecticut Technical Education and Career System Board

CTECS Chairman Trefry requested that Jeffrey S. Wihbey, Superintendent of the Connecticut Technical Education and Career System (CTECS) provide an update. Mr. Wihbey stated that the CTECS Board would be meeting on September 11, 2018, to develop strategic goals.
