A. Report on School Discipline

Chief Operating Officer Charlene Russell-Tucker and Chief Performance Officer Ajit Gopalakrishnan presented analyses of trends in student disciplinary behaviors in Connecticut public schools. The report covered data collection and reporting, sanctions and incidents, suspension rates, suspensions of young students, and an in-depth look at disparities by race/ethnicity. Discussion was held on the use of Electronic Nicotine Delivery Systems (ENDS).

B. Update on Achievement First Bridgeport Academy, Amistad Academy, and Elm City College Preparatory School

A panel consisting of Chief Turnaround Officer Desi Nesmith, Chief Talent Officer Sarah Barzee, Turnaround Bureau Chief Lisa Lamenzo, and Achievement First, Inc. Vice President of Operations and Information Technology Support Laurie Bussmann presented to the Board on the status of (i) student suspension issues, (ii) teacher certification issues, (iii) Teacher Education and Mentoring (TEAM) issues, and (iv) bilingual certification issues. Discussion ensued with questions and answers.

Medical Needs. The committee held discussion regarding the Draft Proposed Resolution on Access to Public School Choice Programs.

CTECS Chairman Trefry requested that Jeffrey S. Wihbey, Superintendent of the Connecticut Technical Education and Career System (CTECS) provide an update.
