Minutes State Board of Education Meeting October 2, 2019

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, October 2, 2019, in Plaza North Meeting Room C and D of the State Office Building, 450 Columbus Boulevard, Hartford, Connecticut.

VII. Report of the Commissioner

The Commissioner announced that the Report of the Commissioner would be presented in three parts to include highlights of activities, student guest presentations, and the sharing of information.

SDE Highlights

- Commissioner Cardona highlighted his visits to classrooms from Grades 1 through 12, as well as meetings with various state agencies, educational partners and legislators as opportunities to collaborate and work together on behalf of students of Connecticut.
- o Commissioner Cardona applauded that the SDE promoted great resources to the districts to celebrate Hispanic Heritage Month.
- o The Commissioner celebrated that the Department's Affirmative Action Plan had been approved by the Commission on Human Rights and Opportunities.

Connecticut History Day Presentation

Commissioner Cardona introduced Reading/Literacy Director Melissa Hickey for the presentation of Connecticut History Day. He thanked Melissa Hickey, Stephen Armstrong, Education Consultant, for organizing the presentation. He thanked Rebecca Taber-Conover, Lindsay Moynihan, Iniya Raja, and Marlena Pegolo for the Connecticut History Day presentation to the Board.

Dr. Hickey introduced Rebecca Taber-Conover, the Head of Public Programs and Connecticut History Day at the Connecticut Democracy Center at Connecticut's Old State House.

Ms. Taber-Conover thanked the Board and Commissioner Cardona for the privilege and opportunity to highlight the achievements of the Connecticut students. Ms. Taber-Conover provided an introduction of the National History Day program and shared that Connecticut has approximately 4,000 students participating in History Day. Of the 4,000, 68 made it to the national contest where 3,000 students competed. Of the 68 Connecticut students, 14 students won a national award or received a national recognition.

CHD Student Presenters

- **Lindsay Moynihan**, Conard High School in West Hartford, won a scholarship to the University of Maryland for her project *Turning a Tragedy into a Triumph: Dolley Madison, the War of 1818, and the Creation of a National Identity.*
- **Iniya Raja**, Timothy Edwards Middle School in South Windsor, won 6th place for *The Eugenic Roles: Dead Souls and Birth Control.*

 Marlena Pegolo, at the time a student at Sedgwick Middle School in West Hartford, won Outstanding Entry in World War I History for her project *The Tragic and Triumphant "Tail" of Stubby, the Military Dog.*

Commissioner Cardona introduced Director of Communications Peter Yazbak to Share Successes.

from the Connecticut Educator Preparation Provider (EPP) Data Dashboard, for the purpose of certifying graduates from USJ in the following areas:

A. Academic Standards and Assessment

No report was presented.

B. Accountability and Support

Dr. López reported that the committee would meet on October 10, 2019. She also highlighted an article about Clinton Avenue School in New Haven on its impressive growth in English Language Arts. Clinton Avenue School was once a struggling school visited by Dr. López and Mrs. Benham as members of the committee. Mrs. Benham was impressed that the leadership knew and taught the curriculum. She stated that Clinton Avenue School is a model for the state. Dr. López also highlighted that social studies teacher Lauren Sepulveda of Clinton Avenue School was the recent recipient of the Connecticut Milken Award of 2019-2020 and \$25,000. A discussion on the role of principals ensued.

C. Finance, Audit, and Budget

No report was presented.

D. Legislation and Policy Development

Mrs. Benham reported that the committee met that morning, but did not have a quorum for an official meeting. She stated that the committee (i) received an update on the Relay ARC program; and (ii) had a discussion as to what other matters the committee would like to see come before it. Mrs. Benham reported that the resolution on funding for all the different schools will be reviewed and will come before the Board in the future.

E. Connecticut Technical Education and Career System Board

CTECS Chairman Trefry introduced Superintendent Jeffrey Wihbey. Mr. Wihbey reported that Commissioner Cardona visited four technical high schools in September and that the visits sent a positive message that has been great for morale of

students and staff. Mr. Wihbey summarized the CTECS Board meeting by stating that enrollment CTECS incoming freshman class has increased. Mr. Wihbey provided a report on the unofficial graduation rate for the last school year.

Mr. Wihbey reported on a ribbon cutting ceremony with Governor Lamont, Senator Richard Blumenthal, and Commissioner Cardona at the brand new Ella Grasso Technical High School in Groton. He highlighted the Partnership Shop with Three Rivers Community College and Electric Boat.
