II. Approval of Minutes

III. New Britain High School, New Britain

Nancy Sarra, Superintendent of New Britain Public Schools and Damon Pearce, Principal of New Britain High School reported on the school's progress. Currently in year three of the Commissioner's Network, Superintendent Sarra acknowledged that the high school has not met the gains they intended three years ago, but reported confidence in the newly adopted learning systems and structures to strengthen building leader support and a focus on fidelity of implementation to improve student outcomes. Principal Pearce shared that Commissioner's Network funding has helped with the sustainability and success of the school's manufacturing academy, which has provided students with the opportunity to go into the manufacturing industry. The school has been working to improve focus areas,

like student suspension rates, by engaging diverse stakeholders to work collaboratively on comprehensive solutions. Furthermore, the school has refocused its efforts on Tier 1 instruction, Accountability and Support Committee Meeting April 22, 2020

investing in building leadership capacity to support and sustain the development and implementation of a culturally relevant and rigorous curricula, and continuing their efforts to improve attendance. The committee thanked Superintendent Sarra and Principal Pearce for their update and recommended that they leverage Commissioners' Network funds to improve identified areas of improvement in order to increase student outcomes.

IV. New Britain CN Planning Schools

Nancy Sarra, Superintendent of New Britain Public Schools and Principals of Pulaski Middle School, Slade Middle Schools, and Smalley Elementary School appeared before the committee to discuss their potential entrance in the Commissioner's Network for the 2021 school year. Division Director Lisa Lamenzo provided the committee an overview of the Commissioner's Network Application process and mentioned the district's need for curriculum as reflected by the initial audits. Superintendent Sarra shared the district's curriculum plan and the steps to ensure it is vertically aligned, equitable and student-centered. This plan includes a focus on Pulaski, Slade, and Smalley School, which is reflected in each of their plans. Superintendent Sarra also expressed her confidence with the leadership of building administrators and the plan to hold them accountable to ensure their plans are implemented.

Pulaski Middle School Principal Johanna Robles described the school's turnaround plan in the areas of talent, academics, culture and climate, and operations. The plan was strategically developed with community needs and sustainability in mind, grounded by the school's vision to provide a safe, equitable, and intellectually challenging environment that will empower all students to become culturally competent, innovative thinkers, creative problem solvers and inspirational learners.

Slade Middle School Principal Todd Verdi shared highlights of their school's turnaround plan. Based on the school's initial audit, the school's turnaround committee developed a plan to create an inclusive and strong social emotional environment for students and staff, restructure student's schedule to maximize instructional time, implement extended learning and intervention opportunities, and provide teachers collaborative planning time. Principal Verdi stressed that equity is a fundamental component to the school's plan.

Smalley Elementary School Principal Andrea Foligno described their school's process in using the Commissioner's Network instructional audit and data as a foundation to the development of their plan. Smalley's turnaround committee identified key priorities and strategies to increase academic rigor, maximize instructional time, strengthen teacher instructional capacity, reduce chronic absenteeism, and strengthen student, family, and staff engagement. The school also mentioned that budget priorities will be based on school needs and sustainability of reform.

The committee thanked the three New Britain schools for their interest in the Commissioner's Network and looks forward in seeing improvement in their school and performance.

V. Hartford High School, Hartford

Dr. Leslie Torres-Rodriguez, Superintendent of Hartford Public Schools, and Hartford High School Principal Kiaundra Smith appeared before the committee to discuss their potential entrance in the Commissioner's Network for the 2021 school year. Superintendent Dr. Torres-Rodriguez described how the turnaround plan aligns with the district's model of excellence, which is a three year configuration of schools across the district. The plan, along with the district model, aims to transform Hartford High School into a comprehensive neighborhood school with a focus on post-secondary success and a long term vision of having the high school become a flagship school for the district and across the state. Using the Commissioner's Network instructional audit and data trends, Hartford High School's plan contains core components including: a freshman academy supporting incoming students transitioning into high school; improving attendance; embedding a social emotional component to support a positive culture and climate and a school environment that is restorative and responsive to the needs of students,

families, community partners, and staff; and developing an alternative day program to meet the needs of over-age and under credited high school students and 9th Grade repeaters.
