Minutes Special State Board of Education Meeting March 16, 2020

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Monday, March 16, 2020, in 2 North Meeting Room B of the State Office Building, 450 Columbus Boulevard, Hartford, Connecticut, and via WebEx conference.

I. Call to Order

Vice Chairperson López explained that the purpose for the meeting were: (i) for the Commissioner to provide updates, and (ii) to inform new Board members of board functions.

II. CSDE Commissioner Update

Commissioner Miguel Cardona thanked the Board for the commitment of attending this meeting. He stated that due to unprecedented times and things changing rapidly, he wanted to utilize the meeting to update the Board. The focus of the meeting was the opportunity to

provide all, especially the new members an overview of the operations of the board and their roles as members.

- The Commissioner reviewed that Governor Lamont had closed all of Connecticut's public schools for two weeks.
- o The CSDE will work with the districts with Federal Guidance as if school will be out longer.
- The CDC's guidance is closer for six to eight weeks.
- o Scholastic reached out with free resources for school closure. Scholastic Learn at Home a free website that provides students with 20 days' worth of learning.
- o The districts are encouraged to contact their Regional Education Service Center (RESC)
- The RESCs have offered to work with the districts.
- The Guidance from last week has changed differently

Commissioner Cardona introduced Legal Director Jessa Mirtle. Legal Director Mirtle thanked the Board members for their support and patience during this unprecedented situation and that information was being shared as available. Legal Director Mirtle stated that she would discuss (i) boardsmanship, (ii) ethics, and (iii) FOIA.

Legal Director Mirtle provided an overview on:

- Board quorum
- E-mails: The appropriate use of e-mails, replying, attorney/client communication, and retention guidance.
- FOIA: Official work of the agency may be requested.

At this time, a new caller joined the WebEx. She identified herself as a reporter.

Ethics

- Statement of Financial Interests (SFI). Yearly request for financial disclosure must be electronically filed with the Office of State Ethics. This provides an opportunity to disclose an interest so as to not be adverse to Board decisions.
- Contributions to political campaigns. By statute, the Board members are collectively a
 department head. A department head has (i) limitations on political fundraising
 solicitations, and (ii) limitations on political contributions in Connecticut.
- Conflict of Interest.
