Minutes State Board of Education Meeting March 3, 2021

(Approved April 7, 2021)

Pursuant to notice filed with the Secretary of the State and posted on the agency's Web site, the members of State Board of Education (hereinafter "Board") met on Wednesday, March 3, 2021, in Plaza North Meeting Room C and D of the State Office Building, 450 Columbus Boulevard, Hartford, Connecticut, and via GoToWebinar. A GoToWebinar registration link was provided to allow for public attendance to the virtual meeting. This virtual meeting was livestreamed (https://youtu.be/91KTTS6Onlo) to allow for public access.

II. Public Participation

A. The Condition of Education in Connecticut 2019-20

Chief Performance Officer Ajit Gopalakrishnan presented an overview and key highlights of the report to the Board. The report presents indicators that describe the progress of the public education system, the characteristics of its students and educators, and student performance on key indicators of student engagement and student readiness for college and careers. This report is required by CGA Section 10-4(b).

In the 2019-20 school year, due to the COVID-19 pandemic, in-person classes were cancelled in mid-March and all districts switched to fully remote instruction for the remainder of the school year. Additionally, all state academic assessment and the Next Generation Accountability System reports were cancelled for the 2019-20 school year.

The Board engaged in questions and answers.

Vice Chair López moved, Board Member Benham seconded, that the State Board of Education, pursuant to Section 10-4(b) of the Connecticut General Statutes, receives *The Condition of Education in Connecticut* (2019-20) and directs the Acting Commissioner to take the necessary action.

VI. Report of the Chair

Chairperson Taylor did not provide a report.

VII. Financial Matters

Chief Financial Officer Demsey reported that the Governor had announced his proposed Fiscal Year 2022-2023 Biennial Budget. She reported that the Department's budget would remain relatively flat over the biennium. She highlighted three key points of the

budget: (i) the education funding formulas have been level funded to the current fiscal year amount; (ii) there was an increase in funding of the per pupil amount for charter schools; and (iii) the separation of the Connecticut Technical Education and Career System (CTECS) from the CSDE will be delayed until Fiscal 2024.

A. Approval of the 2021-22 Concussion and Head Injury Annual Review for Coaches

B. Approval of New Educator Preparation Program: Sacred Heart University, Music Education Program

RESOLVED, That the State Board of Education, pursuant to Section 10-145d-9(g)(3)(A) of the Regulations of Connecticut State Agencies, grants full approval for the period March 3, 2021, through November 30, 2025, to Sacred Heart University (SHU), with annual progress monitoring conducted using program data from the Connecticut Educator Preparation Provider (EPP) Data Dashboard until SHU's next Council for Accreditation of Educator Preparation (CAEP) visit, for the purpose of certifying graduates from SHU in the following new certification area:

X. Items for Discussion

A. Agency Update

Acting Commissioner Russell-Tucker introduced the subject matters that would be presented under the Agency Updates.

Connecticut State Board of Education Five-Year Plan: Introduction

 Chief Strategic Planning Officer Keith Norton updated the Board on the process for the next Five-Year Plan. Mr. Norton reported that the Department has contracted with the Connecticut Center for School Change (CCSC) led by Executive Director Dr. Richard Lemons, to assist the SBE in developing the next Five-Year Plan. Mr. Norton delineated the timeline commencing with the March 2021, Retreat and ending with the final plan being presented for adoption at the June 2022, SBE meeting.

2021 Accountability and Assessment

 Chief Performance Officer Ajit Gopalakrishnan presented on the 2021 Accountability and Assessment. Mr. Gopalakrishnan stated that since his February 3, 2021, update, Connecticut was seeking flexibility from the U.S. Department of Education. He highlighted that flexibilities suggested by the U.S. Department of Education were already being used in Connecticut: (i) shorter test; (ii) remote testing; (iii) extended testing windows for districts to complete their testing.

CT Recognized for Student Performance in Advanced Coursework

• Chief Performance Officer Ajit Gopalakrishnan reported that Connecticut was recognized by the College Board for having the highest percentage among all states for the percentage of graduates scoring 3 percent or better on at least one AP exam in 2020. He noted there was an increase in the number of graduates for students of color and students from low-income families.

Learning Models

 Chief Performance Officer Ajit Gopalakrishnan reported that 57.9 percent of districts were in a predominately full in-person learning model and another 36.5 percent of districts are offering the hybrid model; noting that almost 95 percent of districts are offering some sort of in-person learning opportunity.

ESSER II Update

 Commissioner Russell-Tucker provided an ESSER II update on development of the application to be sent to districts and the process by which the applications will be reviewed by the Department.

Student Voice -Thought Exchange

• Chief Performance Officer Ajit Gopalakrishnan reported on the Thought Exchange run by the Department in December and January. 8,000 students statewide responded to the following question: As you are learning through the Pandemic, what can Connecticut Schools do to make students feel even more connected, energized and enthusiastic about learning this year? The responses had themes that centered on relationships, teaching and learning, and communication and flexibility.

Vaccination Update

• Acting Commissioner Russell-Tucker stated that since the Governor made the announcement that educators and child-care providers are now eligible to receive

vaccinations, the Department reached out to learn from districts on how to support them.

 Division Director John Frassinelli spoke on the work that ensued, working closely with the Office of Early Childhood, the Department of Public Health, the Office of the Governor and CAPSS to make connections with districts that did not have a vaccine partner.

Discussion ensued.

Professional Learning Opportunities for Families and Districts

Acting Commissioner Russell-Tucker reported that the Department has been offering
professional learning opportunities by hosting a series of virtual conversations for
families, highlighting a webinar held on March 2, 2021: Special Education during
COVID-19: Resources, Supports, and Best Practice Strategies, at which over 160
parents participated.

CCSSO Winter Collaborative Presentation

Acting Commissioner Russell-Tucker shared that SDE colleagues were asked by CCSSO to present on work happening in Connecticut at the CCSSO Winter Collaborative: School and District Improvement Collaborative. CSDE Division Director Lisa Lamenzo, CSDE Education Consultant Jennifer Webb, and Hartford High School Principal Kiaundra Smith presented on the following topic: Supporting Districts and Schools in Virtual Environments.

XI. Committee Reports

A. Academic Standards and Assessment

Board Member Clemons reported that the committee met on February 9, 2021. The next meeting will be held on April 13, 2021.

B. Accountability and Support

Vice Chair López reported that the committee met on February 18, 2021 and had two charters present. Also, in attendance was the Office of the Child Advocate to support its advocacy that schools and children with disabilities are provided educational opportunities. The next meeting will be held on April 15, 2021.

C. Finance, Audit, and Budget

Chairperson Taylor reported that the committee did not meet.

D. Legislation and Policy Development

Board Member Benham reported that the committee met prior to this board meeting. The committee had a presentation by Andrea Brinnel on Preschool Oversight Roles.

E. Connecticut Technical Education and Career System Board

Board Chair Trefry reported that CTECS is currently in a hybrid learning model and working to get all student back to in-person learning by April. Superintendent Wihbey is working with 17 the local health departments on returning to school fully in-person as well as on the matter of teacher vaccinations. Mr. Trefry reported that the admission process had migrated to an on-line process, and the application submissions are robust. CTECS is addressing staffing matters.

F. NASBE

Board Member Benham reported that the Whole Child Policy group of NASBE met last month. She stated that Connecticut was immediately recognized for our Position Statement on Culturally Responsive Education. There was a presentation on assessment and grading. There are four areas that are going to be major concerns for boards of education: (i) shortages and layoffs; (ii) the toll of the workforce; (iii) teaching preparatory; and (iv) diversity of the teaching workforce.

G. SERC

Board Member Benham highlighted that Marjorie Davis has been appointed as the Associate Director of SERC. SERC's professional development continues to be busy with racial equity.

Chairperson Taylor adjourned the meeting at 3:28 p.m.
