# Minutes State Board of Education Meeting April 7, 2021

#### X. Items for Discussion

### A. CAPSS Blueprint to Transform Connecticut's Public Schools

Fran Rabinowitz, Executive Director, Connecticut Association of Public Schools (CAPSS), and Paul Freeman, Superintendent, Guilford Public Schools, presented the *CAPSS Blueprint to Transform Connecticut's Public Schools*.

The *CAPSS Blueprint* articulates a comprehensive set of 30 recommendations that CAPSS believes will move Connecticut closer to assuring that every child receives the high-quality teaching and learning which they are owed.

Ms. Rabinowitz and Mr. Freeman requested the Board consider and incorporate the CAPSS recommendations into the framework of developing the SBE's next five-year plan.

## **B.** Agency Update

Acting Commissioner Russell-Tucker introduced and described subject matters that would be presented under the Agency Updates.

#### **CSDE's American Rescue Plan Allocations**

Chief Financial Officer Kathy Demsey reported that Connecticut would receive \$1.1 billion under the American Rescue Plan (ARP).

## **ESSER II Update**

Deputy Commissioner Desi Nesmith provided an update and thanked CAPPS for the partnership to provide Technical Assistance Administrators (TAA) to work directly with district superintendents regarding their federal funding.

## <u>Procurement of Devereux Student Strengths Assessment (DESSA)</u>

Acting Commissioner Russell-Tucker shared that the Connecticut State Department of Education (CSDE) had entered into a partnership with Aperture Education to provide a statewide SEL assessment for K-12 schools. Division Director Glen Peterson provided an overview.

#### Learning Models

Chief Performance Officer Ajit Gopalakrishnan reported that the period of March 29-April 2, 2021, over 70 percent of districts, about 197 districts, are now operating in a predominately fully in-person model; and five districts are operating fully remote. There are only two districts that have not operated in a hybrid or in-person model this year.

#### **Professional Learning Opportunities for Families and Districts**

- Implementing African American/Black and Puerto Rican/Latino Studies in High Schools, to support Social Studies Curriculum Leaders
- Self-Care and Social Emotional Learning (SEL) for Parents and Caregivers (presented in English and Spanish).

## Shoutout!

- Commissioner's Network Ignite Session March 26, 2021. The Turnaround Office brought together 19 schools across 9 districts to highlight impactful strategies from the field celebrating school's to improve outcomes.
- o <u>Comprehensive Center Virtual Learning Series (CCNETWORK)</u>. Topic: How State Departments of Education can leverage principles of design thinking to create an

- ecosystem of support for teaching and learning during a period of rapid transformation.
- o <u>1st Annual Statewide Educators Rising Conference March 31, 2021</u>. Chief Talent Office Shuana Tucker stated that Connecticut launched its own EdRising model in September 2020 and at this first conference there were more than 580 participants.

## **AccelerateCT Education Task Force**

Director of Innovation and Partnerships, Chris Soto presented an overview. AccelerateCT Education Task Force is co-chaired by the CSDE in parallel with the Office of the Governor (OTG). The Task Force will develop a statewide blueprint and programming for school districts and communities to consider as they implement learning acceleration strategies and programs in the short- and long-term.

## XI. Committee Reports

## A. Academic Standards and Assessment

Vice Chair López reported that the committee is scheduled to meet on April 13, 2021.

## B. Accountability and Support

Vice Chair López reported that the committee did not meet in March and would not meet in April.

## C. Finance, Audit, and Budget

Vice Chair López reported that the committee did not meet.

#### D. Legislation and Policy Development

Board Member Benham reported that the committee met and had two updates. One from Division Director John Frassinelli on the Healthy and Balanced Living Curriculum Framework. The second update was by Chief of Staff/Legislative Liaison Laura Stefon on the legislative bills and meetings with committees.

## E. Connecticut Technical Education and Career System Board

Superintendent Wihbey reported that they were gearing up for the reopening of all CTECS schools in May. CTECS did a SWOT (Strengths, Weaknesses, Opportunities, and Threats) Analysis of what needs to be thought about to reopen. CTECS will be working on trade remediation over the summer to include graduating students. Mr. Wihbey reported on the status of the enrollment process for next fall.

#### F. NASBE

Vice Chair López also provided further tribute for former Chairperson Allan Taylor's NASBE leadership. Mr. Taylor was elected as the Northeast Area Director of NASBE in 2014-15 and 2008-09, president-elect of NASBE (2010), and served as NASBE president in 2011. Mr. Taylor was selected by NASBE as a recipient of the 2014 Distinguished Service Award.

Board Member Exley reported that Board members Benham, Reasco, and Exley attended the NASBE Virtual 2021 Legislative Conference held on March 22-23, 2021, and had sent a report to members of the Board.

## G. SERC

Board Member Benham reported that SERC had applied for the W.K. Kellogg's Foundation Racial Equity Grant for 2030 and it has been moved to the next phase.
