State Board of Education Meeting September 1, 2021

(Approved October 6, 2021)

Pursuant to notice filed with the Secretary of the State and posted on the agency's Web site, the members of State Board of Education (hereinafter "Board") held a meeting on Wednesday, September 1, 2021, in Plaza North Meeting Room C and D of the State Office Building, 450 Columbus Boulevard, Hartford, Connecticut. Public access to the building allowed for public attendance at the meeting.

I. Call to Order

Chief Financial Officer Kathy Demsey reported to the Board that this year adjustments are being made to two accounts: (i) Interdistrict Cooperative Grants, and (ii) Interdistrict Magnet Schools.

X. Items for Discussion

A. Agency Update

Commissioner Russell-Tucker provided a summary of some activities at the agency:

ARP ESSER Update

Chief Financial Officer Kathy Demsey provided an update on the Elementary and Secondary School Emergency Relief Funds (ARP ESSER). She announced that on August 27, 2021, the United States Department of Education (USED) approved Connecticut's plan. She also noted that LEA applications for the use of funds were due to the Department on August 16, 2021.

Legislative Update

Chief of Staff/Legislative Liaison Laura Stefon provided a Legislative Session Summary:

- Public Act 21-2 created the Center for Literacy Research and Reading Success within the CSDE under the leadership of the Academic Office; and
- Public Act 21-168 established an Office of Dyslexia and Reading Disabilities within the CSDE under the leadership of the Talent Office.

Vaccinations – Health and Safety

Division Director John Frassinelli provided an update on vaccination requirements under Executive Order 13D and the SDE's FAQ that was provided to school districts to clarify requirements and district responsibilities for covered workers in schools. Also, he spoke on #Vax2SchoolCT Toolkit. The Toolkit is a guidance of steps for school and district leaders to host COVID-19 clinics at Connecticut school districts.

Screening Testing – Health and Safety

Chief Nancy Pugliese spoke on the weekly screening testing programs available for K-12. A period of questions and answers followed.

Assessment Update

Chief Performance Officer Ajit Gopalakrishnan presented a summary on the results of the 2020-21 statewide summative assessments. He reported that the assessment data shows the positive effects of in-person learning over hybrid and remote models: (i) students who learned in-person lost the least ground academically, (ii) those who learned in hybrid or remote models showed substantially weaker achievement and growth during the pandemic; and (iii) growth during the pandemic was weaker in all subjects, but observed differences were largest in mathematics.

X. Items for Discussion

A. SBE Goal 1 - College Enrollment, Credit Attainment and Remediation of High School Graduates (P20WIN Report)

Chief Performance Officer Ajit Gopalakrishnan presented to the Board on the results from P20WIN for the High School Graduating Classes of 2010 through 2016. The scope of the report examined data and answered three studies:

- 1. Enrollment: What percentage of the graduating class enrolled in a Connecticut public university or community college (UCONN, the four Connecticut State Universities, and 12 Connecticut community colleges) within 16 months of graduation?
- 2. Credit Attainment: What percentage of those who enrolled in a Connecticut public university or community college within 16 months of graduation earned at least one year's worth of credits (24 or more) within two years of enrollment?
- 3. Remediation: What percentage of those who enrolled in one of the four Connecticut State Universities or one of the 12 community colleges within 16 months of graduation took a remedial course within two years of enrollment?

Discussion ensued.

XI. Committee Reports

A. Academic Standards and Assessment

Committee Chair Clemons reported that the committee would be meeting on September 14, 2021.

B. Accountability and Support

Committee Chair López reported that the committee would be meeting on September 22, 2021.

C. Finance, Audit, and Budget

No report was presented.

D. Legislation and Policy Development

Committee Chair Benham reported that the committee met that morning and that SDE Attorney Laura Anastasio presented a review on Racial Imbalance procedures.

E. Connecticut Technical Education and Career System Board

CTECS Chairman Trefry reported that two students placed first at the National Skills USA Competition and earned Gold medals. Mr. Trefry announced that Superintendent Wihbey would be leaving CTECS and commended the Superintendent for his leadership which propelled CTECS forward.

F. NASBE

Mr. Exley reported that (i) on August 25, 2021, NASBE hosted a webinar on "Filling the Educator Pipeline" and Dr. Shuana Tucker, Chief Talent Officer was a guest speaker panelist; (ii) the NASBE September 2021 issue cover article is *The Role of Schools in Racial Justice*; and (iii) NASBE has requested that Mr. Exley to be the Northeast Regional Director.

G. SERC

Board Member Benham reported that (i) SERC is very busy with racial equity, (ii) rollout of IEP implementation to special education educators and seeking RFPs; and (iii) on August 23, 2021, SERC hosted the *Virtual House Call for Parents and Families: Return to School Safely During COVID-19*.
