# Connecticut State Board of Education Hartford

## State Board of Education Meeting November 3, 2021

(Approved December 1, 2021)

Pursuant to notice filed with the Secretary of the State and posted on the agency's Web site, the members of State Board of Education (hereinafter "Board") held a meeting on Wednesday, November 3, 2021, in Plaza North Meeting Room C and D of the State Office Building, 450 Columbus Boulevard, Hartford, Connecticut. Public access to the building allowed for public attendance at the meeting.

#### I. Call to Order

Division Director John Frassinelli presented before the Board. Mr. Frassinelli stated that recent legislation called for additional content areas to be included in the health education curriculum. The Framework includes Health Education and Physical Education curricular content for students in pre-K through Grade 12. The 2021 Framework is updated to not only include the additional content areas but is now aligned with the current National Health Education and Physical Education Standards.

Mr. Frassinelli thanked and acknowledged (i) Tracy Stefano, East Hartford Public Schools, (ii) Joseph Gorman, Waterbury Public Schools, and (iii) Joseph Velardi, Connecticut Association of Schools.

## B. African American, Black, Latino, and Puerto Rican Course of Studies Curriculum Update

Chief Academic Officer Irene Parisi, Social Studies Consultant, Stephen Armstrong, SERC Consultants Nitza Diaz and Paquita Jarman-Smith, presented an update to the Board. They reported on the 18 months of planning the course, two sets of workshops for superintendents and teachers, and the launching of a training series. There are approximately 50 schools piloting for next year. They spoke on teacher and school commitment to the implementation, as well as successes and challenges to implementation.

#### C. Fund for Teachers

Dr. Dale Bernardoni, CT Program Director, Fund for Teachers, Christopher Wethje, Director of Human Resources, East Hartford Public Schools, and Hiba Sarfraz, Science Teacher at Sunset Ridge School, East Hartford, presented to the Board. Dr. Dale Bernardoni provided an introduction on Fund for Teachers (FFT). FFT is a national 501(c)3 organization that invests in the professional development of Pre-K through 12<sup>th</sup> grade eligible educators across the country. FFT awards summer fellowship grants and experiential learning opportunities to pursue self-designed professional learning. FFT aims to strengthen instruction by investing in outstanding teachers' self-determined professional growth and development in order to support student success, enrich their own practice, and strengthen their schools and communities.

Mr. Wethje stated that 60 EHPS teachers have been FFT Fellows. He stated that there is no cost to the districts.

Ms. Sarfraz, a 7<sup>th</sup> Grade science teacher was a 2019 FFA recipient and traveled to Costa Rica. Ms. Sarfraz said that you become a life-long learner and a living force.

There was a period of questions and answers. Discussion ensued regarding how to introduce and promote this "no cost" opportunity to districts. Commissioner Russell-Tucker expressed to Dr. Bernardoni that the discussion would be continued.

## A. Agency Update

Commissioner Russell-Tucker provided a summary of agency activities.

#### <u>Introduction of Director of Legal and Governmental Affairs</u>

Commissioner Russell-Tucker introduced and welcomed Attorney Michael McKeon to the Department as the new Legal Director.

#### **ARP ESSER Update**

Chief Financial Officer Kathy Demsey provided an update on the American Rescue Plan, Elementary Assistance to Non-Public Schools (ARP EANS) Program. She summarized that Connecticut received \$15.9 million in aid for Non-Public Schools.

#### **Health and Safety**

Division Director John Frassinelli provided an update on vaccination requirements. He reported that the CSDE continues to work with DPH and promote **#Vax2SchoolCT Toolkit**, the guidance for Connecticut schools and district leaders to host COVID-19 clinics. He highlighted that the FDA had approved the authorization for the Pfizer vaccine for children ages 5-11.

#### Talent Office Update

Chief Talent Officer Shuana Tucker provided updates from the Talent Office.

- CCSSO's Advancing Inclusive Principal Leadership (AIPL) Initiative provides coaching and support to state education leaders. CT was selected as one of five states to partner with CCSSO in Cohort 2.
- Educator Evaluation Feedback Forums. The CSDE is seeking input from educators to support the ongoing review and forthcoming revision of the Guidelines for Educator Evaluation 2017 to help inform the Educator Evaluation and Support 2022 (EES 2022). The RESC Alliance and district partners will be hosting and facilitating six virtual forums to solicit input.
- Chief Tucker applauded Sharon Fuller, Education Consultant on the 2022 Anne Marie Murphy Paraeducator of the Year and the Connecticut 2022 Teacher of the Year public announcement events.
- o Commissioner Russell-Tucker made comments on EdRising.

#### Special Education Update

Division Director Bryan Klimkiewicz, provided an update on the web-based Special Education IEP Data Management System, <u>CT-Special Education Data System</u> and the Special Education IEP Quality Training Topics and compliance with the State Performance Plan (SPP) and Annual Performance Report (APR).

#### 2021-22 FAFSA Challenge

Deputy Commissioner Desi Nesmith provided an update on the FAFSA Challenge. In September, CT launched its second FAFSA Challenge to increase FAFSA completion rates by 5 points by working to have greater partnership and collaboration between high schools and

institutions of higher education. Deputy Commissioner Nesmith concluded that there is a focus on Alliance Districts and charter schools.

#### Voice4Change

Madison Csejka, Commissioner's Office, provided an introduction of Voice4Change. A first-of-its-kind campaign administered by the Connecticut State Department of Education that will empower high school students to decide how 1.5 million of American Rescue Plan Elementary and Secondary Schools Emergency (ARP ESSER) funding will be spent to impact their schools. It will allow students to suggest and have an opportunity to vote on how \$20,000 of the ARP ESSER state set-aside be spent in their school. The students' proposals must align with at least one of the five priorities.

#### Recognition - KnowledgeWorks

- CSDE was recognized in a recent KnowledgeWorks' article, "Strengthening Systems: How States Are Rethinking Human Capital Systems and Technology Infrastructure in the COVID-19 Era."
- Highlighted AccelerateCT Taskforce, efforts to close the digital divide, and minority teacher recruitment.

#### Recognition - 2022 Teacher of the Year

On October 28, 2021, Governor Ned Lamont and Commissioner Charlene M. Russell-Tucker announced that Kim King, a PK-4 Art Teacher in Mansfield at both the Southeast Elementary School and the Annie E. Vinton School, had been selected as Connecticut's 2022 Teacher of the Year.

- Nutrition Efforts.
  - P-EBT: In partnership with the Department of Social Services, the implementation of the Pandemic Electronic Benefits Transfer program has provided more than \$347,350,827 million in food benefits through electronic debit cards.
  - School Meals: September 2021 saw the largest reimbursement to school districts for meals served in the history of Connecticut's school meals programs (16,000 more meals; \$10.5 million more in reimbursements)
- Chronic Absence. LEAP has conducted more than 6,200 home visits with over 2,000 families in 15 school districts.

## E. Connecticut Technical Education and Career System Board

Interim Superintendent Dr. Ellen Solek reported that work is being done on the strategic plan, and on a draft separation and implementation plan. Superintendent Solek highlighted being able to offer the full suite of Google Career Certificates to CTECS high schools. She spoke on the shortage of drivers for W.F. Kaynor Technical High School.

#### F. NASBE

In the absence of Board Member Exley, Vice Chair Benham read the NASBE Report. Mr. Exley attended the Virtual NASBE 2021 Annual Conference. Erin Benham was reelected Northeast Area representative on the nominating committee and Mr. Exley was elected as Northeastern Area Director and as a member of the NASBE Board. He was named chair of the NASBE Government Affairs Committee. He continues to serve as a member of the editorial advisory board. Mr. Exley will attend the NASBE Board meeting on November 9, 2021.

#### G. SERC

Committee Member Benham referenced her SERC report in the Supplemental Folders.

#### H. CT Remote Learning Commission

Board Member Karen DuBois-Walton provided an update. She reported that the Commission met on October 18, 2021. They identified work group committees for the development of Commission tasks.

#### Announcement of Google Career Certificates

Commissioner Russell-Tucker highlighted the October 29, 2021, event that announced the offering of the full suite of Google Career Certificates program available to all community colleges and career and technical education (CTE) high schools. This makes Connecticut the first state in the nation to offer the full suite of Google Career Certificates. Program participants were U.S. Secretary of Education Miguel Cardona, Governor Ned Lamont, President Terrence Cheng, Connecticut State Colleges and Universities (CSCU), Alphabet's Chief Financial Officer Ruth Porat, and Chief Workforce Officer for the State of Connecticut Kelli Vallieres. Also in attendance were Commissioner Charlene Russell-Tucker, U.S. Senator Richard Blumenthal, and U.S. Senator Chris
