B. Final Report of the Ansonia-Derby Temporary Regional School Study Committee

Legal Director Mike McKeon and Staff Attorney Matthew Venhorst presented the report to the Board. Attorney Venhorst provided a brief overview of the regionalization process pursuant to Connecticut General Statute 10-39, that authorizes two or more school districts to join in the establishment of a regional school district. The communities of Ansonia and Derby formed such a Committee with the charge to study the advisability of regionalization and to prepare and submit a written report of its findings and recommendations to the respective towns and the State Board of Education.

The Committee did not make a formal finding as to the advisability of regionalization. Attorney Venhorst noted that on February 6, 2022, the Committee was disbanded by operation of law based on the amount of time that had lapsed since the Committee's inception.
