- 1. Pursuant to Section 10-66bb(a) (2) of the C.G.S., based on legislative appropriation of funds, such charter school may be valid for a period of three years.
- 2. Receipt of all completed documentation relating to facility requirements including safety, liability, and insurance certifications prior to school opening.

3. Receipt of all required and completed documentation relating to incorporation status and identification of governing board members prior to school opening.

And further directs the Commissioner to take the necessary action.

# B. Extending the Flexibilities for Implementing the Connecticut Guidelines for Educator Evaluation 2017 for the 2021-22 School Year into the 2023-24 School Year

**Resolved**, That the State Board of Education, pursuant to Section 10-151d of the CT General Statutes, approves extending the Flexibilities for Implementing the *CT Guidelines for Educator Evaluation 2017* into the 2023-24 school year, and directs the Commissioner to take the necessary action.

# C. Extension of Emergency Certifications for 2023-24

WHEREAS, on March 10, 2020, Governor Lamont declared public health and civil preparedness emergencies throughout the State of Connecticut in response to the coronavirus disease 2019 (COVID-19) outbreak caused by the SARS-CoV-2 virus in the United States and Connecticut; and

WHEREAS, on several occasions since March 10, 2020, acting pursuant to legal authority conferred by the Connecticut General Statutes, and in response to the continued need to respond adequately to the COVID-19 pandemic, Governor Lamont renewed the declarations of public health and civil preparedness emergencies and also issued new declarations of public health and civil preparedness emergencies; and

WHEREAS, with proper protective measures in place, in-person learning provides the best environment for educating our students, and attending school in person provides children with meaningful access to necessary supports for mental health and wellness as well as access to nutrition, shelter and socialization;

WHEREAS, the ongoing challenges of the COVID-19 endemic continue to give rise to unprecedented staffing challenges for schools, with an expectation of continued high levels of vacancies for certified staff members in Connecticut public schools statewide and the Bureau of Educator Standards and Certification continues to trend well above pre-pandemic level requests for temporary authorizations and permits; and

WHEREAS, the consequent potential for these statewide staffing shortages to continue or to reemerge at equal or greater levels in Connecticut public schools beyond the current school year; now therefore be it:

**Resolved**, That the State Board of Education adopts the recommendation from the Connecticut State Department of Education to extend, for the 2023-24 school year only, implementation of the following temporary certification endorsements, as allowable under Sec. 10-145d-619 of *Regulations Concerning State Educator Certificates, Permits and Authorizations* Emergency Generalist, PK-8 (#201), Emergency Generalist, 7-12 (#202), Emergency Teacher of English Language Learners, PK-12 (#204), and Emergency PK authorization for Comprehensive Special Education, K-12 (#205) to allow educators who currently hold and continue to hold during the 2023-24 school year an appropriate provisional or professional

teaching certificate to be eligible for Emergency Authorization at the request of the LEA/District, and directs the Commissioner to take the necessary action.

Note: During the 2020-21, 2021-22 and 2022-23 school years, educators who held a valid initial, provisional, and/or professional certificate were eligible for the Emergency Authorization. The 2023-24 Emergency Authorization, at the request of the LEA/district, may be issued only to educators who hold a valid provisional or professional educator certificate with a teaching endorsement.
