## III. Achievement First Charter Schools Renewal Corrective Action Updates

Irene Parisi, Chief Academic Officer for the CSDE Academic Office, shared a brief overview of the latest State Board of Education (Board) approved charter renewal and the approved corrective action plan for Achievement First (AF) charter schools in April of this year. Ms. Parisi welcomed Achievement First Bridgeport Academy Interim Superintendent Karolyn Belcher; Regional Superintendent of Achievement First Brooke Williams; Elementary School Principal of Achievement First Bridgeport Shalia Garnett; Elementary Principal of Amistad Academy Elementary School, New Haven, Lauren Raimondi; Elementary School Principal of Achievement First Hartford Sueleidy Cruz; Consultant of Team School Operations Achievement First Stacy Gilison; Director of External Relations of Achievement First Nakia Hall; and Chief Academic Officer of Achievement First John Sharkey to provide a progress update per the conditions of their latest charter renewal for:

- Achievement First Bridgeport (AF Bridgeport)
- Achievement First Hartford (AF Hartford)
- Amistad Academy (Amistad)
- Elm City College Prep (ECCP)

AF expressed their gratitude for the technical assistance the CSDE provided with the SBE-approved Corrective Action Plan. AF shared with the Committee that AF charter schools did not experience absenteeism issues until after COVID-19; as result, proceeding COVID-19, AF built and started the implementation of a Multi-Tiered System of Supports (MTSS) for absenteeism. AF added that the MTSS for absenteeism in place helps maintain AF informed to build supports for the months AF charter schools are experiencing high absenteeism rates.

AF noted chronic absenteeism issues in the kindergarten grade level and at Amistad and an increase in the absenteeism rate during the holidays, particularly in the kindergarten grade level. AF will continue efforts to address Amistad's absenteeism rate with the goal of reducing it to 10 percent. AF will continue to focus on building and implementing MTSS for absenteeism. Ms. Parisi suggested AF to look into the Learner Engagement and Attendance Program (LEAP) and encouraged them to continue working alongside Kari Sullivan Custer from the CSDE Attendance, Chronic Absence, and Truancy Office and leverage state funding opportunities. Despite the teacher recruitment challenges AF charter schools are facing in the areas of mathematics and science, recruitment and retention continue to be a priority for AF. AF added that incentives have been created to be competitive in the teacher pool.

AF shared with the Committee that revamping the academic curricula was a massive undertaking and AF successfully revised the English language arts (ELA) and mathematics curricula to align with Common Core State Standards and is providing professional development for teacher knowledge building around the new ELA and mathematics curricula. While mathematics continues to be a challenge because of the teacher shortage in the subject area, AF is starting to observe progress in ELA, according to AF ELA assessments. AF went on to report that reading level for AF elementary school students is steadily increasing and there has been an increase in use of data to guide instruction. Additionally, AF reported ECCP experiencing a 46 percent increase in literacy in the kindergarten grade level and contributed it to the implementation of Science of Reading. AF will continue efforts in ELA and plans to provide further professional development to AF educators around the new curriculum to dive deeper in the curriculum.

Moreover, one of AF's goals for the incoming school year is to strengthen family engagement which was affected by the pandemic. The Committee thanked the AF team for their update. The Pro Temp Chair opened the floor for comments and questions from the Committee.
