State Board of Education Meeting January 3, 2024

Pursuant to notice filed with the Secretary of the State and posted on the agency's Web site, the members of State Board of Education (hereinafter "Board") held a meeting on Wednesday, January 3, 2024, in Plaza North Meeting Room C and D of the State Office Building, 450 Columbus Boulevard, Hartford, Connecticut. I. Call to Order

XI. Items for Discussion

A. Recognition of the 2024 Teacher of the Year and 2024 Teacher of the Year Finalists

Chief Talent Officer Shuana Tucker and CSDE State Teacher of the Year Coordinator Mary Glassman presented to the Board. Ms. Glassman provided an overview of the Teacher of the Year process.

Chief Tucker and Ms. Glassman called each Connecticut Teacher of the Year Finalist to the table and read aloud the bios of each into the minutes of the meeting.

2024 New Haven Teacher of the Year and Connecticut Teacher of the Year Finalist

Marco Cenabre is an English teacher in grades 10-12 at the New Haven Academy.

- Marco's philosophy of teaching is that "As teachers, we are all still students." He was able
 to provide the district's first ever long term paid professional development centered on
 anti-racist and culturally sustaining pedagogy.
- Marco is described as being a "warm demander" because he combines high expectations for all students with a deep concern for their development and well-being. He respects their ability to rise to the challenge of sophisticated work and provides the structure of support needed to meet lofty goals.
- As a district leader, Marco is engaged in equity initiatives at the local and national level and has been awarded numerous fellowships through The Yale Teachers Institute, The Abolitionist Teaching Network, The Ramsden Project and Social Emotional Learning (SEL) in Action. He is a Teacher-Organizer for the Anti-Racist Teaching and Learning Collective (ARTLC). Marco is a graduate of Saint John's University.

2024 Meriden Teacher of the Year and Connecticut Teacher of the Year Finalist

Angela Fragoso serves as a Teacher of English to Speakers of Other Languages (TESOL) at Orville H. Platt High School. She is fluent in English, Spanish, Portuguese, and French.

 In her nomination letter, her supervisors said, "Angela puts her students and their families at the very center of everything she does."

- Angela said she believes that "A classroom is no longer just a place where students come to learn; it's also a safe space where students are supported as individuals and a place that gives them a sense of belonging. With teacher guidance and encouragement, teachers have the potential to truly change the course of a student's life."
- "As I've grown professionally, I realize that many teachers plan and deliver their lessons well; but the superstars, those that leave a lasting impression on students' lives, are teachers that make students feel seen."
- "Throughout my elementary career, it has always been clear to me that I am not just working with a student in my classroom, I am working with a family and a community."
- To help teach students about financial literacy, Angela created a Path to College parent workshop for juniors and seniors. The workshop focuses on helping Spanish speaking parents better understand the college process, saving for college, and identifying college scholarships.

2024 East Granby Teacher of the Year and Connecticut Teacher of the Year Finalist

Olivia Petersen is a social studies teacher at East Granby Middle School. She received her bachelor's and master's degrees from Westfield State University. She is working toward her advanced graduate certificate in Social Justice Education Teacher for Diversity at UMASS Amherst. Olivia said she chose to teach history and social studies because she is passionate about social justice.

- Olivia said, "I see the classroom and school as a community of learners where every voice matters and should be heard. I emphasize with my students the importance of shared space and that all of us are in the same room."
- In nominating Olivia, her colleagues said that Olivia's dedication to her craft is unmatched.
 "Her positive energy is contagious, and she develops a relationship with each student. She ensures that all students have a voice and brings out the best in all our students."
- Mrs. Petersen guides her students with the goal that the content and skills they are learning are not just for their time in the classroom. They all know one of Mrs. Petersen's favorite mantras: Social Studies is for Life.

2024 Connecticut Teacher of the Year Kiana Foster-Mauro

Ms. Foster-Mauro was accompanied by Superintendent Cynthia Ritchie and Principal Jason Foster.

Kiana Foster-Mauro is an educator, activist, and lifelong learner. She is a fourth-grade teacher at Nathan Hale Arts Magnet School in New London and committed to empowering her students through culturally sustaining and human rights centered learning.

 Kiana believes teaching is a radical act that impacts minds and hearts. She has designed and led lessons that empower, center joy, and tackle critical and relevant topics. Kiana has

said, "The world needs more people who come alive. It is up to us to provide our students with the time, space, and tools to discover what makes them come alive."

- Foster-Mauro has presented at conferences, nationally and locally. She has been a member
 of the National Association for Multicultural Education since 2018 and was recently
 accepted to present on facilitating critical conversations around current events, identity,
 human rights, and mental health.
- Kiana is a graduate of the University of Connecticut where she served on the executive board of Leadership in Diversity, a student-led organization dedicated to diversifying education. Outside of the classroom, she extends her commitment to education, diversity, and community as a dance teacher at The Dance Extension and company advisor to the Community Dance Ensemble.
- Kiana believes, "Learning is magic in its rawest form and teachers are magic personified. To witness the innate brilliance within children, to recognize their curiosity and tenacity are keys to a better world and to dedicate one's life to empowering minds and hearts, that is magic."

Ms. Foster-Mauro stated that it was an honor to be named Connecticut's Teacher of the Year. She thanked Mr. Jason Foster, and Dr. Cythnia Richie for being present and for their continuous support throughout this journey.

Chair DuBois-Walton congratulated the Finalists and the 2024 Teacher of the Year and stated that it was a pleasure to have them come before the board.

Commissioner Russell-Tucker stated that it was great to start the New Year celebrating educators. She thanked the teachers for what they do every day.

Introduction of Connecticut Educators Rising Student Cabinet and Representatives Officers.

Chief Talent Officer Dr. Shuana Tucker requested a moment to recognize and celebrate future educators from the Educators Rising Program. She shared that in December the Connecticut Statewide Educators Rising Program installed an inaugural class of officers for the program. Three of the six officers were in attendance.

Chair DuBois-Walton invited the EdRising students to the table.

 - Ms. Afable stated that EdRising has offered her incredible opportunities to further her path to a career in education. EdRising program has grown immensely, providing not only necessary concepts, but clinical experience also, giving high school students incredibly valuable skills that many acquire at the college-level.
- 2. Vice President of Communications: **Mimi Colon**, New Britain Public Schools.
 - Ms. Colon stated that EdRising has created a pathway that she did not know she had before. The opportunities that EdRising has given her, has made her sure that she wants to

become an educator. New Britain EdRising is doing a great job but just because we are doing great, doesn't mean we can't do better.

- 3. Connecticut Representative at Large, Isaias Rodriguez, New Britain Public Schools.
 - o Mr. Rodriguez started with EdRising as a Freshman. He said the program has shown him that he has a passion for changing the culture of education.

Commissioner Russell-Tucker thanked the EdRising students for changing the face of education.
