## I. Call to Order

#### V. Report of the Chair

Chair DuBois-Walton highlighted the following:

- Recognized March as being Women's History Month.
- Shared a Black History moment of her recent trip to Selma, Alabama. Selma was commemorating the 59<sup>th</sup> anniversary of the Selma to Montgomery March for voting rights. It was a weekend full of history and celebration. Reflection on the work of the foot soldiers.
- Highlighted a 16 year-old student currently enrolled in Spellman was the person selected to introduce Vice President Harris for the "Bloody Sunday" memorial.
- Quoted the late Congressman John Lewis, who as a teen was bloodied on the Pettus Bridge on "Bloody Sunday."

#### Karen DuBois-Walton

Chair DuBois-Walton stated that as a Board, it was important to reflect on all that has been accomplished. She highlighted the following:

- Navigated the uncharted territory of the global COVID-19 pandemic.
- Adoption of a new Five-Year Comprehensive Plan for Education 2023-28: Every Student Prepared for Learning, Life, and Work Beyond School.
- Authorized implementation of the African American, Black, Latino, and Puerto Rican Course of Studies
- Launched the development of the Native American curriculum.
- Authorized implementation of the Right to Read legislation, including the review of researched-based K-3 Universal Screening Readiness Assessments and Waiver Applications.
- Joint Position Statement on Equity and Mathematics Education.
- Adopted of the Parent Bill of Rights for English Learners/Multilingual Learners.
- Addressing the educator shortage through the Approval of Extended Reciprocity.
- Extension of Emergency Certifications.

#### A. Approval of New Educator Preparation Program: Capitol Region Education Council, Alternate Route to Certification Program in Mathematics, Middle School, 4-8

Board Member Burr moved, and Board Member Sieve seconded, that the State Board of Education (SBE), pursuant to Section 10-145d-9(g)(3)(A) of the Regulations of Connecticut State Agencies, grants full approval for the period March 6, 2024, through October 31, 2026, to the Capitol Region Education Council (CREC) with annual progress monitoring conducted using CREC's Council for the Accreditation of Educator Preparation (CAEP) annual report data in conjunction with the CSDE review committee until CREC's CAEP fall 2025 site visit, for the purpose of certifying graduates from CREC in the following new certification area and directs the Commissioner to take the necessary action.

## VI. Report of the Commissioner and Agency Update

The Commissioner announced that she had to leave the meeting to testify before the Education Committee. She referenced her written report.

## Postsecondary Earnings

She invited Chief Performance Officer Ajit Gopalakrishnan to the table to present on a new dashboard that was developed on postsecondary earnings of high school graduates going back to 2007. Chief Gopalakrishnan was joined by Katherine Breslin, Outreach and Engagement Coordinator, in the Data and Analytics Unit, Office of Policy and Management (OPM), and Patrick Flaherty, Director of Research, Department of Labor (DOL). He credited the analysis of the report as being possible due to cross-agency collaboration from P20-WIN. Mr. Gopalakrishnan's presentation covered the average earnings of high school graduates' earnings for each graduating class going back to 2007.

Chair DuBois-Walton noted that this aligned with aspects of our Five-year plan.

The Board engaged in questions and answers.

Chair DuBois-Walton returned the agenda to VII, Items Requiring Action.

## B. Renewal of State Charter: Capital Preparatory Harbor School, Bridgeport

Chair DuBois-Walton asked for a motion for agenda item VII.B. Board Member Taylor moved, and Board Member Burr seconded, that the State Board of Education, pursuant to subsection (g) of Section 10-66bb of the Connecticut General Statutes, renews the charter of Capital Preparatory Harbor School, Bridgeport from July 1, 2024, through June 30, 2028, subject to the conditions and recommendations set forth in the Commissioner's March 6, 2024, memorandum to the State Board of Education, and directs the Commissioner to take the necessary action.

Chair DuBois-Walton noted that she presided over the public renewal hearing for Capital Preparatory Harbor.

Deputy Commissioner Dr. Charles Hewes, Program Manager Robert Kelly, with Dr. Steve Perry, Founder and Head of Schools, Dr. Ayanna Carter, Assistant Superintendent for School Leadership CT, and Pastor Kenneth Moales, founding Board member, presented to the Board.

The Capital Preparatory School team spoke in opposition to the CSDE's four-year renewal recommendation and made appeals for consideration of a five-year renewal term.

Board Member Taylor questions the SDE team regarding the four-year renewal as opposed to the granting of a five-year renewal. Dr. Hewes responded to the inquiry.

Vice Chair Benham spoke in agreement with Dr. Hewes. She also voiced her concerns on the suspension rate and that certification continues to not be in compliance from the school's last renewal. She reminded fellow Board members of the four standards being applied to renewals.

The Capital Preparatory Harbor School team engaged in discussions with the Board.

Chair DuBois-Walton called for a vote on the resolution for four-year recommendation. She reminded the Board members that they can act on the resolution, and they also have the ability to amend the resolution if there is a desire.

Board Member Taylor moved, Board Member Prou seconded for an amendment to change the recommendation to a five-year renewal period.

Chair DuBois-Walton requested a vote on the amendment.

Board Member Burr moved, and Board Member Sieve seconded, that the State Board of Education, pursuant to subsection (g) of Section 10-66bb of the Connecticut General Statutes, renews the charter of Great Oaks Charter School, Bridgeport from July 1, 2024, through June 30, 2027, subject to the conditions and recommendations set forth in the Commissioner's March 6, 2024, memorandum to the State Board of Education, and directs the Commissioner to take the necessary action.

Deputy Commissioner Dr. Charles Hewes, Chief Academic Officer Irene Parisi, Program Manager Robert Kelly, with Robert Carlson, Board Chair, John Scalice, Executive Director, and Latoya Hubbard, Chief Operating Officer, presented to the Board.

Vice Chair Benham raised a question regarding the hiring of a bilingual educator. Board Member Prou, who presided over the public hearing renewal, commented on her appreciation of the school's history and growth and noted that the students were impressive, community support at the renewal hearing was quite substantial, and encouraged them to keep up the work.

#### F. Fairfield Racial Imbalance Update

Chair DuBois-Walton called for a motion for agenda item VII.F. Board Member Burr moved, and Board Member Harris seconded, the resolution as follows:

**Whereas**, the Fairfield Board of Education submitted a plan to address the racial imbalance at McKinley School that included the development of a redistricting plan; and

**Whereas**, the Fairfield Board of Education has indicated that it will not pursue a redistricting plan; and

**Whereas**, Section 10-226a(a) of the Connecticut General Statutes (C.G.S.) and Section 10-226e-5(a) of the Regulations of Connecticut State Agencies (Regulations) requires a board of education to develop and implement a plan to address racial imbalance; and

**Whereas**, the Fairfield Board no longer has a plan in place that is reasonably calculated to reduce the racial imbalance at McKinley School; now, therefore, be it

**Resolved:** That in accordance with Section 10-226d of the C.G.S. and Section 10-226e-7(b) of the Regulations, the State Board of Education hereby requires the Fairfield Board of Education to submit an amendment to its Racial Balance Plan within 120 days of this day and no later than July 3, 2024.

Legal Director Mike McKeon and CSDE Attorney Laura Anastasio, with representatives from the Fairfield Board of Education and Fairfield Public Schools were in attendance to present to the Board. Superintendent Michael Testani, Board Chair Jennifer Jacobsen, Vice Chair Nick Aysseh, presented to the Board to address the Proposed Racial Imbalance Plan Update.

Superintendent Testani highlighted scenarios and spoke on the challenges of a viable solution, including the new kindergarten legislation.

The Board engaged Fairfield with questions and answers.
