٧. **Report of the Commissioner and Agency Update**

The Commissioner thanked Principal Lyons-Barton and Superintendent Benigni for hosting the State Board of Education meeting. She referenced her written report and highlighted the following items:

- Hosted Commissioner's Superintendent Advisory Panel meeting.
- o Held Commissioner's Roundtable Meeting for Family and Community Engagement.
- o Presented at the Transforming Children's Behavioral (TCB) Health Policy and Planning Committee Meeting.
- o Provided welcome remarks on the CT Housing Finance Authority's (CHFA) Teacher Homeownership Webinar.
- Held a 3rd Friday call with superintendents, joined by Governor Lamont, DESPP Commissioner Higgins, DEMHS Deputy Commissioner Bergeron, and members of the CT Intelligence Center for discussion on school safety and security and recent school treats.
- o Performance Office launched new Gifted and Talented Dashboard on EdSight.
- o Met with State Board of Education members and the Executive Board of the CT Association of Boards of Education (CABE).
- o Hosted a virtual all-staff Back-to-School meeting for members of Team CSDE.
- o Hosted the annual Commissioner's Back-to-School Meeting for Superintendents.
- o Provided welcome remarks at the annual Special Education Back-to-School Conference.

School Safety and Security

Division Director John Frassinelli, Division of School Health, Child Nutrition, and Family Services presented to the board. He spoke on the following matters:

Mr. Timothy Silva, of the Connecticut Intelligence Center (CTIC), presented to the Board that CTIC was developed after 9/11 to increase collaboration and information sharing among all levels of government. Mr. Silva concluded with methods for assisting leadership, stakeholders and law enforcement in mitigation and decision-making by getting information to the right people.

Update on Hartford Public Schools Fiscal Operations

The Commissioner referenced her commitment to keep the Board updated on its authorized action at the June 5, 2024, meeting concerning Hartford Public Schools Financial Management and summarized the three-prong approach: (i) Magnet School Assessment: Optimizing Funds Utilization; (ii) Special Education Services Assessment and Enhancement; and (iii) Improvement of Financial Systems. She invited Deputy Commissioner Dr. Charles Hewes and Chief Strategic Planning Officer Keith Norton to the table. Dr. Hewes and Mr. Norton presented to the Board.

Dr. Ocasio introduced the 2024-2025 Educators Rising Student Cabinet Officers. The students shared their goals and accomplishments for the year.

The Aspiring Educators from Central CT State University (CCSU)

The CCSU chapter of Aspiring Educators attended the National Aspiring Educators Conference in Philadelphia. The CCSU Chapter won the Emerging Chapter Award.
