#### **XI.** Items for Discussion

#### A. Recognition of the 2025 Teacher of the Year and 2025 Teacher of the Year Finalists

Education Consultant Mary Glassman presented the TOY district nomination process, and was joined by each teacher and their superintendent at the table for the reading of their bios.

Vice Chair Benham read aloud the bios of each teacher into the minutes of the meeting as follows:

#### 2025 Connecticut Teacher of the Year finalist

Jeffrey Helming: Anna Reynolds Elementary School (Newington) Superintendent: Dr. Maureen Brummett, Newington Public Schools Jeffrey teaches second grade at Anna Reynolds Elementary School in Newington. Jeffrey has 24 years of teaching experience. In Newington, Jeffrey is known for his passion for teaching writing. Realizing that motivating young students to write can be challenging, Jeffrey created the Reynolds Writers Contest. Over the years, the contest has included two published collections of student writing with each child creating their own hardcover book. Student writers are celebrated at school events and many students have gone on to receive recognition from the University of Connecticut's Student Writing Contest. In his Teacher of the Year message, Jeffrey said "Every day, teachers have an impact on their students' lives, piquing interests, and challenging minds. When we work together, taking on collective goals with, and for, our students and communities, amazing things happen."

#### 2025 Connecticut Teacher of the Year finalist

Superintendent: Dr. Leslie Torres-Rodriguez, Hartford Public Schools
Yasmin is a second grade teacher at West Middle School in Hartford. Yasmin has been
teaching for 8 years. Yasmin is involved in her school community and developed a weekly
elementary style radio station called "Hawk Nation Station," which was named after the
school mascot. The goal of each weekly program is to get students involved and participating
in the school community. On the program, students share some of their favorite school
events from the past week and give shoutouts to teachers and classmates. Students
regularly ask to participate in the weekly radio program. Yasmin also works to bring students
into the community through local field trips and brings the community to the students by
inviting high school athletes to share their experiences through sports. She also finds ways to

incorporate families into the classroom by inviting them to share their experiences and traditions.

#### 2025 Connecticut Teacher of the Year finalist

Damayanti Rane-Castrodad: Winthrop STEM elementary Magnet School (New London) Superintendent: Dr. Cynthia Ritchie, New London Public Schools Damayanti is a fifth grade teacher at Winthrop STEM Elementary Magnet School in New London and has been teaching for three years. She believes in crafting immersive and culturally sustaining learning opportunities that uphold students' self-love, belonging, social awareness and empathy while elevating their academic success. She designs curriculum to highlight various cultural groups. Damayanti recently initiated a partnership between her students and the University of Connecticut to support their annual HuskyThon fundraiser to benefit Connecticut Children's Medical Center. To raise funds, the Grade 5 students created a "Character Day" where students bring their favorite storybook character to life and also started a recycling can drive. Students then participated in a campus tour at UConn to attend the fundraiser and to talk about career choices and college readiness, which helped students visualize themselves on a college campus. Damayanti is also a coach for Girls on The Run, which focuses on teaching life skills such as self-esteem, positive friendships and problem solving.

#### 2025 Connecticut Teacher of the Year Award Honoree

Superintendent: Dr. Madeline Negrón, New Haven Public Schools
The 2025 Connecticut Teacher of the Year is Julia Miller, a high school Social Studies teacher
at Metropolitan Business Academy in New Haven. Julia has been teaching for 18 years and is
a native of New Haven and a proud New Haven public school parent. Julia is committed to
the practices of antiracist education and project-based learning. As a longtime Civics teacher,
Julia's goal for her students is for them to become informed and active community members
who feel empowered to make change.

In addition to teaching Civics at Metropolitan, Julia also teaches in the Academy of Law, Leadership & Political Science. She co-designed and co-teaches an innovative course entitled Youth Justice in Practice (YJP). Grounded in the theories of restorative and transformative justice, YJP is the senior capstone class in the law pathway. As part of YJP, students run the Metro Youth Justice Panel, a student-led restorative justice initiative in the school that aims to repair harm, provide accountability, and support students who make mistakes in the building.

Julia also helped launch another new initiative in her district: a "Grow Your Own" model to nurture the next generation of New Haven Public **School** teachers. Over the last two years, Julia has supported the development of a new Education and Leadership Pathway. Last year, she ran an after-school program for aspiring educators, which included her teaching Quinnipiac University's Intro to Public Education course to her high school students for dual credit. She was part of a small group of curriculum writers who crafted an Early College Experience course entitled Seminar in Education through a collaboration with Southern Connecticut State University, a course she is now teaching at her school. Julia currently serves as one of two district Teacher Leaders with the national organization Educators Rising.

Vice Chair Benham thanked the teachers and expressed that their bios are the work that our teachers do.

Commissioner Russell-Tucker expressed her appreciation to the teachers and stated that they are remarkable educators whose work transforms lives and are the champions for each student who walks into the classroom.

Chief Academic Officer Irene Parisi presented on the launch of the comprehensive K-12 Model Digital Citizenship Curriculum, designed in partnership with Common Sense Education, providing high-quality standards-aligned resources to foster how students and educators engage to navigate digital literacy with technology.

#### CSDE's Cell Phone and Personal Technology Guidance

Commissioner Russell-Tucker shared that a survey had been conducted on personal technology use policies. She noted that data showed that personal technology policies are working and having an impact.

#### **Dual Enrollment Update**

Commissioner Russell-Tucker provided an update that dual credit enrollment is increasing with more students earning college credits by high school graduation.

#### Update on Hartford Public Schools Fiscal Operations

The Commissioner referenced her commitment to keep the Board updated on its authorized action at the June 5, 2024, meeting concerning Hartford Public Schools Financial Management and summarized the three-prong approach: (i) Magnet School Assessment: Optimizing Funds Utilization; (ii) Special Education Services Assessment and Enhancement; and (iii) Improvement of Financial Systems. She invited Chief Strategic Planning Officer Keith Norton, Deputy Commissioner Dr. Charles Hewes, Special Education Division Director Bryan Klimkiewicz, and Director of Internal Audit Monique Coates to present to the Board.

#### <u>Special Education Presentation – Guest Presenter</u>

Nate Levenson, President of New Solutions K-12, presented preliminary findings, initial thoughts and recommendations, and next steps related to their review of special education in Hartford Public Schools.

The Board members engaged in questions and answers.

#### Rate Setting for Outplaced Special Education Services

Chief Performance Officer Ajit Gopalakrishnan presented on setting rates for outplaced special education services. He pointed out the challenges and unpredictability for districts and noted CSDE's engagement with CCERC to better understand the pros and cons of rate setting.
