### Update on Bridgeport Public Schools Action to Address District Needs

Commissioner Russell-Tucker presented an overview of the CSDE intervention. She then highlighted and updated on the progress of work with the Technical Assistance Team, entrance conference with the superintendent and members of the team, Bridgeport Board of Education required training that has started with CABE, the transparency of local reporting at monthly board meetings, hosting of listening session with students, and highlighted her open letter to the Bridgeport community.

She shared information on the following items:

- Highlighted that Governor's proposed Senate Bill 1244 empowers the CSDE to create a methodology to determine and set tuition rates.
- Visted Middletown High School to meet with students on entering the teaching profession, the importance of diverse educators; creating a sense of culture of community within the school.
- Office of Dyslexia and Reading Disabilities invited students and educators to join digital illustrator and author Krista Weltner for a read-aloud of her picture book series, Everyday Adventures with Molly and Dyslexia.
- Announced an initiative that will transform how students engage with technology in the classroom by launching an innovative artificial intelligence (AI) in education pilot program.
- Guest on WICC's Melissa in the Morning to discuss the State Board of Education's decision to intervene in Bridgeport Public Schools and what it means for the district.
