### **State Board of Education Meeting**

#### June 11, 2025

Pursuant to notice filed with the Secretary of the State and posted on the agency's website, the members the of State Board of Education (hereinafter "Board") held a meeting on Wednesday, June 11, 2025, in Plaza North Meeting Room C and D of the State Office Building, 450 Columbus Boulevard, Hartford, Connecticut. #### I. Call to Order

Vice Chairperson Erin Benham called the meeting to order at 9:35 a.m.

Vice Chair Benham welcomed Dr. Alice Pritchard, Executive Director of the Connecticut Technical Education and Career System (CTECS), as the CTECS representative on the Board.

## II. Public Participation

Dr. Melissa Hickey, Director of the Center for Literacy Research and Reading Success, provided an introduction of the two-year SSACE Literacy Project. She highlighted that last year, June 5, 2024, SSACE presented on their ideas with "*Enhancing Literacy Rates in the State of Connecticut*."

## State Student Advisory Council on Education (SSACE) End-of-Year Presentation

The SSACE students presented their two segments of (1) Enhancing Literacy Rates: Peer Mentorship; and (2) Suicide Prevention. A copy of the presentation is in the official file of this meeting.

The students presented the gaps in literacy among youth data; the initial goals of Peer Mentorship; the QtA teaching method; the process and results of Methodology of Tutoring; and the next steps for statewide implementation.

## V. Report of the Commissioner and Agency Update

The Commissioner provide the following updates to the Board.

#### Federal Transition

The Commissioner presented updates on federal transition actions related to education.

## United States Office of Civil Rights (OCR)

The OCR has notified three CT districts of initiating investigations into possible Title IX violations related to the transgender student athletic policy.

<u>Grant Funding</u> - The Department continues to access funding without interruptions for federal programs administered from both the U.S. Department of Education and the U.S. Department of Agriculture for Child Nutrition Programs.

<u>COVID Funding</u> - The Department had received liquidation extension approval for the department and districts for utilization of COVID funds. The extension was subsequently rescinded on March 28, 2025. The department has submitted 11 projects that were previously approved.

#### **Discretionary Grants**

The Department is now receiving preliminary allocations for federal programs we administer, such as the Individuals with Disabilities Education Act (IDEA).

- Provided opening remarks for Lieutenant Governor Bysiewicz's Computing Challenge Recognition Event at Quinnipiac University
- Presented at Havard University on Chronic Absence and how CT is addressing chronic absenteeism
- Kari Sullivan attended an event connecting attendance and health at John Hopkins and presented on chronic absenteeism work being done in CT
- ❖ Promoted the 4<sup>th</sup> Annual PK-12 School Staff Appreciation Digital Backpack Initiative

#### Windsor Public School's Mobile Classroom

Chief Academic Officer Irene Parisi presented on the launch of Windsor Public School's Mobile Classroom that travels to different community spaces. She applauded Superintendent Terrell Hill and Assistant Superintendent Noha Abdel-Hady for their innovative approach to bring school to the community.

#### Update on Hartford Public Schools Fiscal Operations

The Commissioner invited Chief Strategic Planning Officer Keith Norton to present to the Board. He summarized that it was initially at the June 5, 2024, meeting that the Board voted and authorized action concerning Hartford Public Schools Financial Management and the three-prong approach: (i) Magnet School Assessment: Optimizing Funds Utilization; (ii) Special Education Services Assessment and Enhancement; and (iii) Improvement of Financial Systems.

Mr. Norton reported that at the March 5, 2025, meeting Public Works, LLC presented its final report and that at the May 7, 2025, meeting, New Solutions K-12 presented key findings of their review of special education in Hartford Public Schools.

#### Magnet School Assessment

The Office of Internal Audit is in the final stage of reviewing data and documents from HPS.

#### Special Education

Division Director Bryan Klimkiewicz reported that the Special Education update encompasses three areas: (1) Professional Development and Technical Assistance; (2) Enhanced Monitoring Activities; and (3) IEP Implementation.

#### Improvement of Financial Systems

Deputy Commissioner Charles Hewes reported on the financial services, and noted that Public Works, LLC colleagues Dr. JoAnn Cox and Ms. Betty Ressel were on standby virtually for Board questions.

Deputy Commissioner Hewes summarized that since March 5, 2025, Public Works, LLC had increased its technical assistance to HPS to target the 46 recommendations outlined in the *Fiscal Servies Review Executive Summary of the Final Report*, with a focus on budget creation and grants planning, as well the purchasing and payroll processes.

## <u>Update Bridgeport Public Schools – Action to Address District Needs</u>

Deputy Commissioner Charles Hewes referenced the report in the Board's Supplemental Folder and presented an overview of the CSDE intervention commencing with the January 22, 2025, Special State Board of Education meeting, that authorized the Commissioner to take action in order to support the district of Bridgeport. Dr. Hewes then provided an update on the three interventions (1) establishing a Technical Assistance Team; (2) professional development training for the members of the Bridgeport Board of Education; and (3) the opportunity to work with the district with the Commissioner reserving the right to approve of the hiring of a new superintendent.

Deputy Commissioner Hewes highlighted five categories of actions:

- 1. Financial and Human Resources Procedures and Decision-Making.
- 2. Facilities and Maintenance.

#### Facilities and Maintenance - Nutrition

Division Director John Frassinelli, School Health, Nutrition, and Family Services, reported on conducting an administrative review of the program in 2024 that looked at policies and procedures and implementation of the federal Child Nutrition Programs. He reported that they conducted two full days of listening sessions with students at six different schools. The students raised issues of concern on menu awareness, limited options, meal quality concerns, portion sizes. Mr. Frassinelli stated that it is important to know that every student in every school in Bridgeport can have breakfast and lunch for free.

- 3. School Climate.
- 4. Regular and Special Education Instruction.
- 5. Operational Efficiency and Effectiveness of the Bridgeport Board of Education is a CABE initiative, and not the Technical Team.

Deputy Commissioner Hewes highlighted the need to fill vacancies within the district, address the budget deficit, and ensure family-focused community engagement opportunities. He referenced the newsletter and partners at SERC and summarized next steps.

Board members engaged in discussion.

### 2025 Legislative Session Update

The Commissioner invited Chief of Staff and Legislative Liaison Laura Stefon to present a summary on the legislative session and status of legislative bills. Ms. Stefon reported on bills that passed, SBE expansion items included in the budget, and major bills that did not pass.

The Commissioner stated the need for the Department to know and be aware of every task assigned to the Department from any related bills that were passed from session.
