#### III. Executive Session

There was no executive session held.

Vice Chair Benham asked for a motion to move agenda item XI.A., Recognition of the 2025-2026 Educators Rising Student Cabinet and Aspiring Educators Program, to present on the agenda. Board Member Record moved, and Board member Burr seconded, that agenda item XI.A., be moved.

#### XI. Items for Discussion

# A. Recognition of the 2025-2026 Educators Rising Student Cabinet and Aspiring Educators Program

Chief Talent Officer Dr. Shuana Tucker, Education Consultant Dr. Jessica Ocasio, and Elizabeth Sked, Education Issues Specialist, CEA, presented to the Board. They explained that the Educators Rising and Aspiring Educators Programs are a direct connection to the state's efforts to increase the diversity of Connecticut's educator workforce.

Dr. Ocasio presented on the Connecticut Educator Rising program pathway which provides students with early exposure, skill development, and mentorships for aspiring educators to bridge students in middle and high school to college to consider teaching as a vocation.

Elizabeth Sked, Education Issues Specialist, CEA, presented on her role as advisor to the State Aspiring Educator Program and two Aspiring Educators, Hannah Spinner, and Rebecca Singleton presented on their program experiences.

The Board members engaged in discussion.

#### VIII. Items Requiring Action

Vice Chair Benham introduced Assistant Attorney General Darren P. Cunningham as counsel for the Connecticut State Board of Education, for agenda item VIII.A.

#### A. Capital Preparatory Schools' Petition for a Declaratory Ruling

Vice Chair Benham asked for a motion on agenda item VIII.A., Capital Preparatory Schools' Petition for a Declaratory Ruling.

Board Member Burr moved, and Board Member Harris seconded, that pursuant to Connecticut General Statues Sections 4-5, 4-166(a), and 4-176, the Connecticut State Board of Education hereby declares as follows with respect to the requested rulings set forth in Capital Prep's March 14, 2025, Petition for Declaratory Ruling.

- 1. Funding authority for charter schools rests solely and absolutely with the General Assembly under Connecticut General Statutes §10-66bb(a)(2).
- 2. Neither Connecticut General Statutes Section 10-66ee(k) nor any other provision of the Connecticut General Statutes creates or invests in the State Board of Education or the

Connecticut State Department of Education any funding authority, obligation, or right independent of or in addition to the General Assembly's sole and absolute funding authority under Connecticut General Statutes Section 10-66bb(a)(2).

- 3. Connecticut General Statutes Section 10-66ee(k) applies only to those schools that the General Assembly has expressly funded pursuant to Connecticut General Statutes Section 10-66bb(a)(2). Therefore, as the General Assembly did not fund Capital Prep, Section 10-66ee(k) is inapplicable to Capital Prep.
- 4. Connecticut General Statutes §10-66ee(k) is applicable if, and only if, the General Assembly specifically funds more than one charter school in any fiscal year pursuant to Connecticut General Statutes §10-66bb(a)(2), and then is limited solely to those charter schools that, unlike Capital Prep, the General Assembly has expressly funded.
- 5. The criteria upon which all charter-school applicants are rated pursuant to Connecticut General Statutes §10-66bb(c) pertain solely to the application for the initial certificate of approval under Section 10-66bb(a)(1) and do not mandate or otherwise control General Assembly funding decisions.
- 6. The criteria set forth in Connecticut General Statutes §10-66ee(k) applies only to schools that the General Assembly has specifically funded pursuant to Connecticut General Statutes §10-66bb(a)(2). Therefore, given that the General Assembly expressly declined to fund Capital Prep, it was not a charter school under Connecticut law and Section 10-66ee(k), including but not limited to the criteria set forth therein, does not apply to Capital Prep.
- 7. Having not been funded by the General Assembly pursuant to Connecticut General Statutes §10-66bb(a)(2), Capital Prep was not and is not a charter school under either Section 10-66bb(a)(2), Section 10-66ee(k), or any other provision of the Connecticut General Statutes, nor is it legally entitled to be deemed a charter school.
- 8. The General Assembly having expressly declined to fund Capital Prep pursuant to Connecticut General Statutes §10-66bb(a)(2), Capital Prep was not and is not entitled to any funding from either the State Board of Education or the Connecticut State Department of Education under either Section 10-66bb(a)(2), Section 10-66ee(k), or any other provision of the Connecticut General Statutes.
- 9. The State Board of Education and the Connecticut State Department of Education acted lawfully in declining Capital Prep's demand for funding.

In conjunction with the foregoing rulings, the State Board further directs that the Commissioner, through the Connecticut State Department of Education's Division of Legal and Governmental Affairs (DLGA), take the necessary actions:

#### A. Academic Standards and Assessment

Vice Chair Benham reported that the committee met on September 23, 2025, with updates on AI pilot and K-12 World Language Curriculum.

## **B.** Accountability and Support

Committee Chair Benham reported that the committee met on September 10, 2025, with a review of the ASC and Commissioner's Network monitoring, and review of the charter school renewal process. The committee will next meet on November 12, 2025.

### C. Finance, Audit, and Budget

Board Member Burr reported on behalf of Committee Chair Harris. Chief Strategic Planning Officer Keith Norton and team were acknowledged for their work, status updates, and efforts towards staffing. The committee will meet on November 18, 2025.

## **D.** Legislation and Policy Development

Committee Chair Burr reported that the committee met today before the Board meeting with two presentations.

### E. Connecticut Technical Education and Career System Board

Dr. Pritchard, Executive Director, reported that CTECS data reports 11,700 students in the system, which is 500 more than last year. She noted a slight uptick in special education and highlighted special education training across the state for teachers on October 9, 2025.

#### F. NASBE

Vice Chair Benham reported on the two Member Exchanges held since the last Board meeting, and thanked Board members Record and Labas for attending. She announced that NASBE's 2025 Friend of Education will be presented to Secretary Miguel Cardona.

## G. SERC

Vice Chair Benham referenced her written report. She highlighted SERC's work with special education and noted SERC's availability to assist CTECS with special education.

### V. Report of the Commissioner and Agency Update

Commissioner Russell-Tucker referenced her written report in the Board's Supplemental Folders.

- o Announced EdSight's new Seal of Biliteracy Dashboard that will be presented at a future meeting.

#### **Industry Recognized Credentials**

The Commissioner invited Deputy Commissioner Charles Hewes to present. He reported that the SDE Team identified the state's first list of more than 300 industry recognized credentials that are currently available to students across the state. He highlighted that the intent of this is to make sure districts know what is available so they can design programming to support students in a postsecondary career opportunity in earning these credentials.

#### Update on Hartford Public Schools Fiscal Operations – Financial Analysis of Hartford

The Commissioner invited Chief Strategic Planning Officer Keith Norton to present to the Board. He reported that in July 2025, the agency had created the Hartford Public Schools Accountability and Support Team that was comprised of team members from across the agency and that the Team will provide technical assistance to HPS in meeting the recommendations identified in the final reports of the New Solutions K12 and Public Works LLC. He summarized that the Team has held two meetings with the new HPS superintendent and CFO, and the final report is being processed.

Board Member Zimmerman raised a comment on discussing differential need across schools related to *Sheff*.

## <u>Update Bridgeport Public Schools – Action to Address District Needs</u>

Deputy Commissioner Charles Hewes referenced the report in the Board's Supplemental Folder and presented an update of the ongoing work and day-to-day support of the district by the Technical Assistance Team, related to the 34 recommendations noted in the forensic audit. In addition to continuing work alongside the district related to their fiscal processes, he highlighted accomplishments such as getting teachers into classrooms - reducing vacancies from 120 down to 40; and the Commissioner's leadership in getting students access to busses. He concluded with next steps concentrated on supporting the Bridgeport Board of Education, with the assistance of CABE, around the board's governance and the development of a robust set of policies; and (2) the design and development of the operational budget.

Board members engaged in discussion.

#### Federal Update

The Commissioner presented updates on federal grant awards during the federal shutdown.
