III. Items Requiring Action

A. Connecticut Technical Education and Career System Section 10-4b Complaint Final Report

Vice Chair Benham asked for a motion on agenda item III.A. Board Member Record moved, and Board Member Harris seconded, that in accordance with Section 10-4b of the Connecticut General Statutes, as well as Section 10-4b-8 of the Regulations of Connecticut State Agencies, the State Board of Education ["SBE"] hereby resolves as follows: 1) There is reasonable cause to believe that the Connecticut Technical Education and Career System

(CTECS) failed to implement the educational interests of the State of Connecticut during, at least, the 2024-2025 school year; 2) CTECS has implemented measures to redress and cure its actions during the 2024-2025 school year pertaining to student admission and retention; 3) based upon the foregoing two findings, CTECS is directed to provide the CSDE's Office of Legal and Governmental Affairs with quarterly updates during the 2025-2026 school year regarding admissions, student withdrawals, and in-year Planning and Placement Team and Section 504 Team decisions that would result in the removal of special education and/or Section 504 students from CTECS; and 4) the current Section 10-4b complaint remain open and active until such time either during or following the 2025-2026 school year the CSDE can provide a follow-up report to the State Board, recommending either the closure of this matter, continued monitoring, or the referral of CTECS to a panel of the State Board for further proceedings, including an inquiry.

Director of Legal and Governmental Affairs Mike McKeon, presented.

Commissioner Russell-Tucker provided an introduction of Executive Director Dr. Allice Pritchard, Connecticut Technical Education and Career System (CTECS).

Dr. Pritchard thanked Director McKeon and the Board for the report and their efforts. Dr. Pritchard highlighted the implementation of the blind lottery, and Superintendent Michael Crocco joining the CTECS team. She stated that the CTECS team is focused on moving forward in the right direction and building relationships with districts.

The Board members engaged in discussion. Dr. Pritchard responded to questions.
