#### Connecticut's Autism Guidebook Release

#### **Delivering Specially Designed Instruction (SDI)**

This opportunity will include 4 half day trainings on the planning, delivery and data collection of SDI. Limited technical assistance will be provided in between trainings. November 1, December 6, 2021 and January 10, and February 7, 2022 9:00-12:00 pm

#### **ADOS Training**

The introductory training will be a hybrid program with 5 half-day live/synchronous sessions presented via zoom plus 15 hours of asynchronous training modules to be completed in between live sessions, for a total of 30 hours. Training will begin in January 2022. Specific dates TBD.
