Subject: Adoption of Revisions to Public Act 24-41

Revisions to Public Act 24-41

Introduction

In 2024, Public Act 24-41 Sec. 51 identified a number of regulations to be repealed as of July 1st, 2026. This deadline has been extended to July 1st, 2027. Upon a year-long review process, the Connecticut Educator Preparation and Certification Board (CEPCB) and State Board of Education (SBE) have determined that this list of regulations for repeal must be amended.

Rationale for Adopting this Proposal

The Connecticut Educator Preparation and Certification Board and State Board of Education have reviewed all the regulations initially set to be repealed by PA 24-41. This legislative proposal would revise PA 24-41 to update the list of repealed regulations. The revisions fall into three categories:

A) Regulations that may be allowed to sunset.

PA 24-41 did identify a number of regulations that were appropriate to repeal, including regulations regarding provisional educator certificates that are no longer offered or continuing education units that are no longer required. This proposal maintains those regulations among the list to be repealed.

B) Newly identified regulations that must be repealed.

In addition to these, CEPCB and SBE identified additional regulations to repeal. These include regulations for provisional educator certificates in an expanded number of endorsement areas as well as endorsement areas that are no longer offered. This proposal adds these regulations to the list to be repealed.

C) Regulations that must not be repealed.

Finally, it was found that some of those regulations set for repeal in the Public Act must be maintained in regulation, either as written or with amendments. The maintenance of these regulations serve a variety of purposes including bringing regulations in line with current law, supporting continuity of current practices, and giving additional flexibility to educators. Regulations that required amendments are currently in the process of regulatory approval. This proposal removes this set of regulations from the list to be repealed.

Furthermore, if the regulations are allowed to be repealed, their replacement language would generate new regulation numbers. This would lead to this section of regulations becoming disjointed, out of order, and more difficult to follow.

The details for individual regulations and their status is included for reference in the [Regulations Organizer for CEPCB 5.3.2026](#) attachment. This work was done by the CEPCB in order to advance the legislative mandate in PA 24-41 to propose regulations and legislations with cognizance of educator preparation and certification.

Conclusion

Following a year-long review, the Connecticut Educator Preparation and Certification Board (CEPCB)

and the State Board of Education (SBE) have determined that the list of regulations slated for repeal by PA 24-41 Sec. 51 must be revised. The CEPCB should support this legislative proposal as a continuation of its regulatory work.
