She added that as an educator, educators of color are equally prepared as their counterparts as teachers. Ms. Jorden concluded her remarks by stating that EPPs should not be handling out certifications in a piece-meal type fashion.
- Joy Colon, an educator of color with 26 years of experience, stated that lowering the bar should not be an approach adopted as a plan for diversifying the educator workforce in

Connecticut.
