Action on Presented Regulations/Legislative Language – Kristen Basiaga provided a detailed presentation regarding PA-24-41 revamp of grade spans:

- Secondary range would move from grades (7-12) to grades (4-12).
- ➤ Section 10-145d-432 Provisional educator certification was not slated for repeal by PA 24-should be recommended for repeal as Provisional Certificates are no longer offered by SDE for educators entering the profession.
- ➤ Section 145d-434 Recommended for reinstatement as written to and not be permitted to sunset as it provides information on when an elementary certification is required.
- ➤ Section145d-435 (a) should be reinstated as it requires educators to have an elementary certification and prohibits an educator from being the sole provider for Art, Health, Music, or Physical Education for elementary school students.
- ➤ Section 145d-435(b) Should be edited to reflect the change in grade range expansion to pre-K to six.
- ➤ Section 10-145d-449 -450 -This section covering when a Secondary Academic Certification is required needs updating to conform crossing out grades five and six to statute.
