o CT will no longer use Praxis Core for certification purposes.

Change language from "administered to approved"

ACT, GRE, SAT, and other tests are approved the state board.

The decision can be determined by policy created by each EPP.

Various recommendations for wordsmithing language in the area of testing regulations to reflect updates/changes made by statute.

Discussion Ensued

Initial Educator pathway requirements via the traditional EPP route if subject area is completed.

Transcript Experience Pathway should be reinstated because many educators use this pathway to acquire the initial certification.

An educator can waive the requirement4 for a recommendation from the planned program of preparation by serving under a 90-day certificate: graduates of ARC programs such as Charter Oak may use the 90-day certificate and gain a recommendation from the superintendent at the employing board of Education that authenticates the educator has successfully completed a 90-day certificate.

- Interim Educator Certificates An educator who holds an endorsement in one area and has completed a planned program of preparation outside of CT is required to fulfill the special education requirement to obtain certification in various endorsement areas.
- An applicant who possesses all requirements for the issuance of the initial educator certificate but lacks a course of study in special education may obtain an interim educator certificate with a deficiency.
- Durational Shortage Area Permit Must finish 36 hours of special education courses.
- O Initial Educator certificate now remains active for 10 years not 1 year. There are 2 ways to acquire an extension: the assessment reviewing team that reviews the educator's performance can issue or if the educator may show good cause to the commissioner.

Sarah Lahr Fitzsimons motioned to move forward and approve what was completed so far today.

Kristen Basiaga motioned to amend the previous motion to bring forward 404 and 412 as edited in the chat and 412A to the CEPCB as amended in our discussions.
