- CPRL Educators of Today & Tomorrow: The Vision, and Vision-Aligned Educator Preparation and Certification
- Scheherazade Salimi, Tong Hui Koh, and Liz Chu presented a view of what an educator of today is now and in the future based on research that identified 4 roles that educators should fill: Facilitator, Problem Solver, Collaborator, and Leader
