## **ACCREDITATION 101**

In order to meet Connecticut certification requirements, all required coursework must result in credit awarded on the official transcript of a **regionally accredited** college or university. What does this mean?

There are many accrediting agencies in the United States. These agencies develop criteria for evaluating postsecondary institutions to ensure they meet basic quality standards. But there are many types of accreditation. For coursework or degrees to meet Connecticut requirements, accreditation by one of six important regional accrediting agencies (see box) is required pursuant to Connecticut statute. It is important to note that accreditation by national and/or state level accrediting bodies accepted by the US Department of Education is not sufficient and cannot be accepted to meet Connecticut certification requirements. Information about a school's accreditation is usually found in the school catalog.

Several online resources can help you determine whether a school is appropriately accredited.

- The Council for Higher Education Accreditation (CHEA)
  maintains a searchable database of institutions accessible to
  the public at <a href="https://www.chea.org">www.chea.org</a>. Entering the name of a school
  delivers a list of all bodies accrediting the institution. You
  must then check that list to be sure the appropriate regional
  agency is listed.
- College Source Online maintains a similar online database at <a href="www.collegesource.org">www.collegesource.org</a>. Once you have located the institution, click on the profile icon. This database includes a separate category for regional accreditation, making it easy to determine if the school holds appropriate accreditation.
