School Performance Best Practices	
1. In 250 words or less, what best practices are employed by the school that have contributed significantly to the academic success of students? Our school's academic success has been driven by a set of interconnected best practices centered on culture, clarity, and capacity-building. First, we have prioritized a responsive-to-data culture, using regular data cycles to identify student needs early and adjust instruction in real time rather than waiting for end-of-unit or end-of-year results. This data-driven approach is paired with an improved adult culture focused on results, where staff hold shared ownership over outcomes and use data conversations to drive collective problem-solving rather than individual accountability alone. We've also worked deliberately to increase clarity of expectations for both adults and students, ensuring that instructional practices, behavioral norms, and academic goals are consistently understood and reinforced across classrooms and grade levels. On the instructional side, we implemented the CourseMojo AI tool in middle school to support all learners within our Wit and Wisdom ELA curriculum, providing differentiated scaffolds and practice that meet students where they are. We also added summer school programming at Bridgeport elementary and middle school levels to prevent learning loss and provide additional support for students who need it most. Finally, we've invested in our people: a strong focus on talent development and retention ensures experienced, well-trained staff remain in our building, and we've participated in shared cohort professional development with CT principals and academic deans throughout the year to strengthen instructional leadership across our network.	
2. What is the school intended to improve through its best practices? Through our best practices, Bridgeport Academy intends to improve academic achievement by using data-driven instruction and clear expectations to strengthen learning outcomes for all students. The school also aims to increase its effectiveness in meeting the needs of all learners, ensuring tools like the CourseMojo AI platform and summer school programming reach students at every level of readiness.	

Equally important is the school's commitment to continuing to develop and retain teacher and leader talent, recognizing that sustained academic gains depend on a stable, well-trained staff. Investments in professional development and shared leadership learning across the CT network support this goal directly.

Finally, these efforts are intended to drive strong student retention and fuel public demand, reflected in growing family waitlists. When families see consistent academic results and responsive support for their children, they are more likely to stay enrolled and recommend the school to others — reinforcing its reputation and long-term sustainability.

3. How does the school provide evidence that the best practices are yielding an improvement?

The school provides evidence of improvement through multiple, complementary sources rather than relying on a single measure. One key source is "bright spot" classrooms, where strong practices are visibly translating into student outcomes — evidence that extends beyond this charter to patterns observed across our broader network of 10 schools and 4 charters, reinforcing that these practices are effective and replicable.

The school also gathers evidence by examining student work directly, using it to identify concrete signs of growth over time in skills, understanding, and application of learning — providing a tangible, ground-level view of progress that complements broader data trends.

Finally, the school captures qualitative evidence by listening directly to its community, gathering feedback from students, teachers, and parents through surveys and listening sessions. This input offers insight into how improvements are being experienced day-to-day, surfacing perceptions of culture, support, and instructional quality that quantitative data alone may not capture.

We have made significant improvement over the past several years, going from 52.1% of our students chronically absent in 2021–22 to 27.3% in 2024–25. While this is evidence that our strategies are working, we recognize that there is more work to do. We will continue revisiting, improving, and enforcing our strategies to bring this number down further and meet our school's goal.

Achievement First Bridgeport Academy's instructional program is grounded in rigorous, standards-aligned instruction; high-quality instructional materials (HQIM); data-driven lesson planning and assessment; targeted intervention and enrichment; teacher coaching and professional development; and ongoing communication with students and families. Across subjects, teachers use state- and nationally recognized HQIM, formative and summative assessments, student work analysis, and regular data-review cycles to identify instructional priorities, plan reteaching, and provide additional supports. Intervention includes small-group instruction, additional reading and mathematics support, co-teaching, and differentiated instruction informed by IEPs and assessment data. The school's College & Career strategy also includes Match & Fit advising, college and career exposure, academic preparation, SAT readiness, and alumni support.

AF Bridgeport's 2024–25 Next Generation Accountability results show several areas of strength and improvement. One hundred percent of students participated in qualifying college- and career-readiness coursework, exceeding the 75% state target, while the percentage meeting the college- and career-readiness exam benchmark increased from 36.3% to 49.5%. Chronic absenteeism continued to decline to 27.3% for all students and 29.9% for students with high needs, compared with rates above 50% in 2021–22. Postsecondary entrance increased from 62.7% to 63.6%, arts access increased from 24.7% to 35.2%, and physical fitness assessment participation reached 99.4%, exceeding the 90% participation target.

Academic performance remains an area for continuous improvement. In 2024–25, the ELA Performance Index was 59.2 for all students and 58.9 for students with high needs, while mathematics was 49.1 and 48.5, respectively; science performance was approximately 49. Academic growth and progress toward English proficiency also remained below state targets. In addition, 34.0% of ninth-grade students were on track to graduate; the four-year graduation rate was 89.4%; 16.6% of students met the physical fitness standard; and arts access, postsecondary entrance, chronic absenteeism, and college- and career-readiness exam performance remained below their respective state targets.

Accordingly, AF Bridgeport's continuous-improvement priorities include academic achievement and growth, progress toward English proficiency, chronic absenteeism, college- and career-readiness exam performance, ninth-grade on-track-to-graduation, four-year graduation, postsecondary entrance, physical fitness outcomes, and arts access. The school will continue implementing its standards-aligned curriculum, assessment and data-review practices, intervention and enrichment structures, teacher development systems, College & Career programming, and student and family communication practices.

Financial Sustainability: Our budget planning process includes conservative revenue and expense assumptions and we develop budget targets for schools to remain in overall operating budget balance. We update our forecasts monthly and report on financial results and forecasts to the board at least quarterly. We use the Workday Adaptive system for budget planning fed by actuals from Sage Intacct for our core accounting and bookkeeping functions.

Fiscal Oversight: AF has sound fiscal practices and policies which are regularly updated and staff are regularly trained on our policies and procedures. We maintain segregation of duties for key financial functions and regularly report on financials to our board as well as ensure board approval of large purchases.

Financial Practices Effectiveness: We have consistently received unmodified opinions from our auditors and, supported by substantial philanthropy, have maintained sustainable operations in Connecticut despite very limited per pupil rate increases from Connecticut over the past decade. These financial systems and governance practices support responsible stewardship of resources and provide leaders with the information needed to make timely, sustainable financial decisions.

Governance and Community Partnerships: Under the leadership of our Executive Director, who serves as head of the Connecticut Region, we have adopted a more proactive and consistent approach to external communication and engagement, particularly with local Boards of Education. This investment has strengthened relationships with key Connecticut stakeholders and positioned AF to support effective stewardship and accountability through stronger local engagement.

Bridgeport Academy serves a diverse student population reflecting the surrounding region. In 2025–26, total enrollment included a student body that is 51.1% Black and 44.6% Hispanic/Latino. The percentage of students eligible for free or reduced-price lunch increased from 70.8% to 80.6% over the past three years, reflecting continued service to economically disadvantaged families and a consistently high-need student population. Enrollment has remained relatively stable while maintaining this demographic composition.

To attract and enroll students, Bridgeport Academy conducts outreach through information sessions, open houses, community partnerships, neighborhood canvassing, and targeted communications with families across the region. To support equitable access and retention, Bridgeport Academy provides targeted supports for Multilingual Learners through language services, family engagement, and multilingual communication, while students with disabilities benefit from Tier 2 and Tier 3 interventions, differentiated supports, and ongoing family partnership designed to promote student success and persistence.

AFBA advances educational equity through targeted recruitment, family engagement, and student support systems designed to ensure access and persistence for historically underserved students. Recruitment efforts resulted in 255 lottery offers for the 2026–27 school year and a waitlist of 64 students. In 2025–26, AFBA served 1,054 students, including 80.9% eligible for free or reduced-price lunch, 16.4% Multilingual Learners, and 14.5% students receiving special education services. The student population is 51.1% Black and 44.6% Hispanic/Latino, and AFBA serves a substantially higher percentage of Black students than the local district.

A key retention strategy is the use of family engagement surveys and annual Intent to Return surveys, which help identify concerns early and inform school improvement efforts. Cross academy partnerships and family engagement support matriculation from 4th to 5th grade and 8th to 9th grade. AFBA also provides targeted supports for Multilingual Learners and students with disabilities through language-access services, family engagement, intervention systems, and ongoing progress monitoring. These efforts have contributed to stable enrollment and a decrease in choice attrition, which declined from 61% of withdrawals in 2023–24 to 55% in 2024–25.

AFBA maintains a system-wide compliance approach grounded in federal and state requirements, supported by structured identification procedures, monitoring systems, and coordination across special education and multilingual learner services.

For special education, the AFBA employs special education teachers, supported by paraeducators. Achievement First provides related services including speech-language pathology, occupational therapy, and physical therapy, with oversight by the Dean of Special Services. Section 504 plans are managed by special education teachers at the middle school and a compliance manager at the elementary level, with annual meetings, three-year documentation reviews, and involvement from the school nurse and social worker as needed. Families are engaged in planning when students enroll, and communication is maintained throughout the process.

For multilingual learners, AFBA implements established EL/ML identification procedures, including timely identification, language proficiency assessment, and assignment of language acquisition plans. EL/ML students receive services based on language needs, delivered through co-teaching and targeted instruction. Progress is monitored through ELlevation and LAS Links, with results communicated to families in multiple formats and supported through translation and interpretation services, including Language Line. AFBA also uses ELAC oversight to ensure timely assessment administration and monitoring of student progress.

AFBA provides ongoing coordination between ESL and general education teachers, and TESOL-certified staff support peer professional learning. Additional professional development is available upon request through

external providers, including RESC, CAPELL, and CALAS. Additionally, during our charter renewal visit, CSDE's shared the following feedback: EL/ML identification, service delivery, assessment administration, and family communication are implemented with fidelity and within required timelines.

Overall, compliance systems are supported through structured staffing, LEA collaboration, formal monitoring tools, and documented procedures across special education and multilingual learner programs.

We recognize the need to further strengthen student academic outcomes, particularly in mathematics achievement, foundational skill development, and on-track graduation indicators. To address this, AFBA is continuing to strengthen instructional practices, targeted intervention systems, and progress monitoring to support continuous academic improvement for all students. In addition, to improve on-track-to-graduation outcomes, schedule improvements have been made so that all 9th grade students will be positioned to take 7 credits, strengthening early credit accumulation beyond the state's 6-credit on-track indicator.

Our goal is to support families in feeling informed and supported throughout the entire enrollment journey from the very beginning of their relationship with us.

These efforts are reinforced through discipline huddles, where school and network leaders review incidents, determine appropriate interventions, and engage families in supporting student success. In addition, principals, academic leaders, and culture leaders participate in data deep dives to analyze behavioral trends and address

		disparities, while we partner with network school climate support leads to ensure strong implementation of behavior systems and policies. These efforts have contributed to improvement in suspension outcomes, with AFBA's suspension rate decreasing from 8.0% in 2022-23 to 7.4% in 2023-24, moving closer to the state average of 7.0%. AFBA will continue to strengthen these systems and supports to further improve student behavior outcomes and school climate.

To the Board of Directors

Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Achievement First Bridgeport Academy, Inc., which comprise the statement of financial position as of June 30, 2025, and the related statements of activities and changes in net assets, functional expenses, and cash flows for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of Achievement First Bridgeport Academy, Inc. as of June 30, 2025, and the changes in its net assets and its cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS") and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Achievement First Bridgeport Academy, Inc. and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Achievement First Bridgeport Academy, Inc.'s ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the schedules of expenditures of federal awards and state financial assistance are fairly stated, in all material respects, in relation to the financial statements as a whole.

Other Reporting Required by Government Auditing Standards

Note 1 - Nature of operations

Achievement First Bridgeport Academy, Inc. (the "Academy") was incorporated to prepare every student to excel in college and career, deepen their knowledge of self and community, and lead lives of purpose. In partnership with their families and communities, the Academy works to disrupt the legacy of inequity in education. On June 25, 2007, the State Board of Education in the State of Connecticut granted the Academy a charter which has been renewed through June 30, 2026. The Academy's primary sources of income are per pupil and other governmental funding. The Academy serves students from low-income households in Bridgeport, Connecticut. In fiscal year 2025, the Academy operated classes for students in grades K-12.

Note 2 - Summary of significant accounting policies

Basis of presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Net assets and revenues, expenses, gains and losses are classified based on the existence or absence of donor-imposed restrictions. Accordingly, net assets of the Academy and changes therein are classified and reported as follows:

Net assets without donor restrictions represent available resources other than donor-restricted contributions. Included in net assets without donor restrictions are funds that may be earmarked for specific purposes.

Board-designated net assets represent net assets established by the Board of Directors, which represents funds without donor restrictions set aside for future needs of the Academy. The Academy aspires to have a reserve of 2.5% of its annual budget at any time. Cash basis operating surpluses, if they exist at year-end, may be used to accumulate the board-designated reserve. Utilization of the reserve may be approved by the Board of Directors and used for emergency funds in case of an unexpected financial crisis, start-up costs for growth needs, facility capital requirements, principal-in-residence salaries and one-time projects which have significant future potential. The reserve balance will be generated from the school's budgeted per-pupil operating revenue, excluding state and federal nonoperating grants.

Net assets with donor restrictions are subject to donor- (or certain grantor-) imposed restrictions which are temporary in nature, such as those that will be met by the passage of time or other events specified by the donor. Other donor-imposed restrictions are perpetual in nature, where the donor stipulates that resources be maintained in perpetuity.

Statement of cash flows

For purposes of reporting cash flows, the Academy considers all highly-liquid debt instruments purchased with an original maturity of three months or less to be cash equivalents. There were no cash equivalents at June 30, 2025.

Grants and other receivables

Grants receivable represent amounts owed to the Academy for federal or state funding. Grants receivable that are expected to be collected within one year, and recorded at net realizable value, are \$343,461 at June 30, 2025. Other receivables that are expected to be collected within one year, and recorded at net realizable value, are \$661,612 at June 30, 2025. The Academy has determined that no allowance for uncollectible accounts receivables is necessary as of June 30, 2025. Such estimate is based on management's assessments of the creditworthiness of its donors, the aging of its receivables as well as current economic conditions and historical information.

Revenue recognition

Contributions are classified as either conditional or unconditional. A conditional contribution is a transaction where the Academy has to overcome a barrier or hurdle to be entitled to the resource and the resource provider is released from the obligation to fund or has the right of return of any advanced funding if the Academy fails to overcome the barrier. The Academy reports unconditional promises to give as revenue when the promise is received. Conditional promises to give are recognized as revenue when the condition is met. Grants and contributions received are recorded as with or without donor restrictions depending on the existence and/or nature of any donor restrictions. When a restriction expires (that is, when a stipulated time restriction ends or purpose restriction is accomplished), net assets with donor restrictions are reclassified to net assets without donor restrictions and reported in the statement of activities and changes in net assets as net assets released from restrictions. Donor-restricted contributions whose conditions and restrictions are met in the same reporting period have been reported as support increasing net assets without donor restrictions in the statement of activities and changes in net assets.

Grants may be considered an exchange transaction or a conditional/unconditional promise to give. Federal, state and private awards are used to finance education programs and capital improvements. The Academy recognizes conditional grants to the extent that eligible grant costs are incurred. Receivables are recognized to the extent costs have been incurred, but not reimbursed for conditional grants. Unconditional grants are recognized upon receipt of notification of the award. Receipts of grant awards in advance, which are payable back to the funding agency if not used, are classified as refundable advances in the accompanying statement of financial position.

The Academy receives a substantial portion of its support and revenue from the State Department of Education. If the charter school laws were modified, reducing or eliminating these revenues, the Academy's finances could be materially adversely affected.

Contract revenue

Contract revenue is primarily derived from special education services provided by the Academy to students from the City of Bridgeport and surrounding towns that are sent to the Academy.

The Academy charges the City of Bridgeport and surrounding towns for special education services based on the services prescribed in each student's individualized education plan. The Academy bills the towns quarterly for reimbursement of the costs of special education services provided, which are treated as a single performance obligation. The special education services are provided continuously over the course of the school year. Revenue is recognized by the Academy quarterly based on meeting the performance obligations. Invoices related to these services do not have any payment terms.

The portion of services provided, but not yet paid by the towns, is recorded as accounts receivable and is reported as an asset on the statement of financial position. The outstanding receivable balance related to these services was \$661,470, \$463,316, and \$119,566 as of June 30, 2025, 2024 and 2023, respectively.

Donated goods and services

The Academy occasionally receives contributed goods and services. Such goods and services are only recorded as in-kind contributions at their fair value, provided they meet the criteria for recognition. Such criteria includes contributions of services that (i) create or enhance nonfinancial assets or those that require specialized skills, (ii) are provided by individuals possessing those skills, and (iii) would typically need to be purchased, if not provided by donation, and are recorded at their fair value in the period received. Contributed services received from Board members and volunteers are not recorded in the financial statements since these services do not meet the criteria for recognition as contributed services.

Property and equipment

Property and equipment are stated at cost. The Academy has established a threshold for review of expenditures equal to or greater than \$3,000 for potential capitalization as a fixed asset. Maintenance and repairs are charged to expense as incurred; major renewals and betterments are capitalized.

Depreciation and amortization are provided on a straight-line basis over the lesser of estimated useful lives or lease terms as follows:

Long-lived assets

The Academy recognizes an impairment loss when the carrying amount of a long-lived asset exceeds its fair value. In the event that facts and circumstance indicate that the carrying amounts of long-lived assets may be impaired, an evaluation of recoverability would be performed. The evaluation process consists of comparing the estimated future undiscounted cash flows associated with the asset to the asset's carrying amount to determine if a write down is required. If the review indicates that the asset will not be recoverable, the carrying value of the asset would be reduced to its estimated realizable value. There was no impairment loss recognized for the year ended June 30, 2025.

Debt issuance costs

Debt issuance costs, net of accumulated amortization, are reported as a direct deduction from the face amount of the mortgage loan payable to which such costs relate. Amortization of debt issuance costs is reported as a component of interest expense and is computed using an imputed interest rate on the related loan.

Functional allocation of expenses

The statement of functional expenses presents the natural classification detail of expenses by function. Accordingly, certain costs have been allocated among the programs and supporting services benefited based on management's assessment. Health and retirement benefits and payroll

taxes are allocated to programs based on the percentage of salary expense of the program to total salary expense. Other expenses are allocated based on time and effort.

Tax-exempt status

The Academy is exempt under Section 501(c)(3) of the Internal Revenue Code ("IRC") and is exempt from private foundation status under IRC Section 509(a)(3) and as such is not subject to federal or state income taxes.

Management has analyzed the tax positions taken by the Academy and has concluded that, as of June 30, 2025, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Academy's federal information returns prior to fiscal year 2022 are closed and management continually evaluates expiring statutes of limitations, audits, proposed settlements, changes in tax law and new authoritative rulings.

If the Academy has unrelated business income taxes, it will recognize interest and penalties associated with any tax matters as part of the income tax provision and include accrued interest and penalties with the related tax liability in the statement of financial position.

Prior year summarized information

The financial statements include certain prior year summarized comparative information in total, but not by net asset class. Such information does not include sufficient detail to constitute a presentation in conformity with accounting principles generally accepted in the United States of America. Accordingly, such information should be read in conjunction with the Academy's financial statements for the year ended June 30, 2024, from which the summarized information was derived.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Concentrations of credit risk

The Academy maintains cash and cash equivalent balances in two financial institutions. Accounts at each institution are insured by the Federal Deposit Insurance Corporation. From time to time, the Academy's balances may exceed these limits. At June 30, 2025, the Academy's uninsured bank balances totaled \$6,624,714. The Academy limits its credit risk by selecting financial institutions considered to be highly creditworthy.

Reclassification

Certain amounts in the 2024 financial statements have been reclassified to conform to the 2025 presentation.

Subsequent events

Management has reviewed subsequent events through December 23, 2025, which is the date the financial statements were approved and available for issuance.

Note 3 - Liquidity

The Academy regularly monitors liquidity required to meet its annual operating needs and other contractual commitments. As of June 30, 2025, the Academy has the following financial assets available to meet annual operating needs for the next fiscal year as follows:

These financial assets are not subject to any donor or contractual restrictions. The Academy supports its general operations primarily with Federal and state grants, which are restricted as to use, state and local per pupil funds and contributions without donor restrictions and contributions with donor restrictions whose time or purpose restriction has been met.

Note 4 - Concentrations

The Academy currently receives approximately 99% of its operating revenue, which is subject to specific requirements, from the Federal and State Departments of Education. Additionally, the Academy's grants and other receivables consist of approximately 26% from the State Department of Education.

Note 5 - Prepaid expenses

On May 21, 2021, the Academy entered into Power Purchase and License agreements for the installation of solar panels on the roof of a school. The Academy prepurchased power in the amount of \$138,504 which will be amortized over the life of the contract which terminates on the twentieth anniversary of commercial operations date. The middle school's solar panels commenced operations in December 2021. This agreement will terminate in December 2041. As of June 30, 2025, the remaining prepaid balance is \$117,728.

The equipment is owned by a third party, Solar Electric Generating Facility ("SEF") and the Academy purchases the power generated. The Academy provided SEF with a licensing agreement to access the premises for maintenance of the equipment. The ownership of the equipment will transfer to the Academy after completion of the 15th anniversary of the commercial operations date. The Academy has the ability to a buyout of the value of the environmental attributes of the agreement starting in year seven.

Note 6 - Leases

The Academy leases office equipment. All contracts that implicitly or explicitly involve property, plant and equipment are evaluated to determine whether they are or contain a lease.

At lease commencement, the Academy recognizes a lease liability, which is measured at the present value of future lease payments, and a corresponding right-of-use asset equal to the lease

liability, adjusted for prepaid lease costs, initial direct costs and lease incentives. The Academy has elected and applies the practical expedient available to lessees to combine nonlease components with their related lease components and account for them as a single combined lease component for all its leases. The Academy remeasures lease liabilities and related right-of-use assets whenever there is a change to the lease term and/or there is a change in the amount of future lease payments, but only when such modification does not qualify to be accounted for as a separate contract.

The Academy determines an appropriate discount rate to apply when determining the present value of the remaining lease payments for purposes of measuring or remeasuring lease liabilities. As the rate implicit in the lease is generally not readily determinable, the Academy estimates the risk-free rate as the discount rate. The Academy's risk-free rate, which is determined at either lease commencement or when a lease liability is remeasured, is the rate on the U.S. government securities over a period commensurate with the lease term.

For accounting purposes, the Academy's leases commence on the earlier of (i) the date upon which the Academy obtains control of the underlying asset and (ii) the contractual effective date of a lease. The commencement date for most of the Academy's office equipment leases coincides with when the Academy obtains control of the underlying assets. The Academy's leases generally have minimum base terms with renewal options or fixed terms with early termination options. Such renewal and early termination options are exercisable at the option of the Academy and, when exercised, usually provide for rental payments during the extension period at then current market rates or at pre-determined rental amounts. Unless the Academy determines that it is reasonably certain that the term of a lease will be extended, such as through the exercise of a renewal option or nonexercise of an early termination option, the term of a lease begins at lease commencement and spans for the duration of the minimum noncancellable contractual term. When the exercise of a renewal option or nonexercise of an early termination option is reasonably certain, the lease term is measured as ending at the end of the renewal period or on the date an early termination may be exercised.

Leases involving equipment

Office equipment leases have lease terms that generally range from two years to five years and generally do not have renewal options. Rental payments on these leases have fixed payments.

Note 8 - Related party transactions

The Academy entered into an Academic and Business Services Agreement (the "Agreement") with Achievement First, Inc. ("AF"), a not-for-profit organization dedicated to helping start and run charter schools. This Agreement provides management and other administrative support services to the Academy.

Pursuant to the terms of the Agreement, the Academy pays a service fee equivalent to 10% of all eligible public revenues received by the Academy during or for that school year. Public revenues include all sources of revenue from a public source, but specifically exclude in-kind contributions such as student transportation, start-up funding, funding for student meals, and funding from competitive public grants. The term of the Agreement is through the charter renewal date of June 30, 2026. The Agreement automatically renews to coincide with the charter renewals. The Agreement covers services including bookkeeping, facilities acquisition and management, special education delivery support, data analysis management support, and tutoring program support. The Academy is to pay AF an ancillary services fee that is mutually negotiated by the Academy and AF. For the year ended June 30, 2025, the Academy incurred management and ancillary service fees of \$1,860,043 which are included in the accompanying statement of functional expenses.

AF passed through miscellaneous grants to the Academy in the amount of \$525,245 for the year ended June 30, 2025. At June 30, 2025, the net amount due to AF was \$905,387.

Note 9 - Due from/to other schools

The Academy entered into a Cooperative Arrangement Agreement (the "Arrangement") with Amistad Academy, Inc. ("Amistad"), a nonprofit charter school located in New Haven, Connecticut. The Arrangement provides educational services to high school students of the Academy and sets forth the terms and conditions of the joint program. Under the Arrangement, Amistad was permitted to pay operating expenses incurred and then bill the Academy for a proportionate share of those costs. The proportionate share is based on the number of students enrolled in the high school as of October 1 divided by the total enrollment of the high school as of the same date.

Note 10 - Mortgages payable

In August 2018, the Academy entered into a loan with a foundation for \$2,500,000. The proceeds, net of debt issuance costs of \$40,293, were used to refinance current debt for real property improvements. The loan bears no interest through the first five years, at which time the loan will bear interest at a fixed rate of 2% since August 2023. Monthly payments commence in August 2024 per the loan agreement, and the loan matures in August 2028. The loan is secured by a first mortgage on the property and assignment of leases and rents. The balance on this loan as of June 30, 2025 was \$1,841,891, net of debt issuance costs. The amortization of debt issuance costs for the year ended June 30, 2025 was \$2,008. Interest expense at June 30, 2025 was \$37,511.

Note 11 - Pension plan

Effective September 1, 2007, the Academy adopted a 403(b) profit sharing plan (the "Plan") which covers the employees not covered by the Connecticut State Teachers' Retirement Board Plan (the "TRB Plan"). The Plan is a defined contribution plan. Employees are eligible to enroll in the Plan upon employment. Those employees who have completed at least one full year of service are also eligible for employer contributions. The Plan provides for the Academy to contribute up to 4% of an employee's salary per employee. The Academy contribution is not vested until the employee's third year, when they become fully vested. For the year ended June 30, 2025, pension expense for the Academy was \$53,810, which is included in retirement in the accompanying statement of functional expenses.

Certain employees of the Academy are required to participate in a defined benefit plan established and administered by the Connecticut State Teachers' Retirement Board. The Academy is not required to and does not contribute to the TRB Plan.

Note 12 - Net asset with donor restrictions

Net assets with donor restrictions may be purpose or time restricted. For the year ended June 30, 2025, net assets with donor restrictions were restricted for the following purposes to be used in the next fiscal year:

Note 13 - Conditional grants

During the year ended June 30, 2021, the Academy received the American Rescue Plan Elementary and Secondary Schools Emergency Relief ("ARP ESSER") Funds grant in the amount of \$5,161,694. Prior to June 30, 2025, \$3,543,890 of grant revenues were recorded related to this grant. The remaining balance of the grant will not be recorded as the Academy did not meet the conditions of the grant before the expiration of the grant period.

Note 14 - Risk management

The Academy is exposed to various risks of loss related to torts; thefts of, damage to and destruction of assets; actions by employees and parents and natural disasters. The Academy maintains commercial insurance to protect itself from these risks.

The Academy entered into contractual relationships with certain governmental funding sources. The governmental agencies may request return of funds as a result of noncompliance by the Academy. The accompanying financial statements make no provision for the possible disallowance or refund, because management does not believe that there are any liabilities to be recorded.
