IMPLEMENTATION TIMELINE

Deadline	Action
February 2025	The CSDE releases the Commissioner's Network Expression of Interest Application Form.
March 2025	LEAs submit completed Expression of Interest on behalf of eligible schools.
April 2025	The CSDE initially selects schools for possible participation in a Commissioner's Network planning year.
June 2025	LEAs for selected schools and bargaining units select members to establish a Turnaround Committee.
September - October 2025	The CSDE conducts an initial audit of the schools selected for possible participation in a Commissioner's Network planning year.
January - April 2026	The selected school Turnaround Committees draft the proposed Turnaround Plan and negotiate necessary flexibilities.
May - June 2026Selected schools present proposed Turnaround Plans to the State Board of Education for approval, pending legislative authorization.
