PreK–12 Education Reopening Subcommittee



Connecticut State Department of Education

- This subcommittee is charged with providing recommendations related to the guidelines that would enable local school districts to safely reopen their schools.
- These recommendations would enable the Governor to announce a plan by May 20th that takes precautionary steps towards a safe reopening in the fall.
- This plan would prioritize public health and safety, ensure educational inequities are not exacerbated, and integrate the thinking of all other subcommittees.





Regional Advisory Teams





- RESC Directors organize recommendations/ considerations from six separate weekly meetings with various educational stakeholders into major themes/trends to share with CSDE.
- RESC Directors meet with CSDE Deputy Commissioners every week to share recommendations and considerations.

 Commissioner of Education uses updates to inform Governor's Statewide Reopen Task Force.

- <u>Volume 1</u>: Content specific resources to support student learning organized by both discipline and grand band.

- <u>Volume 3:</u> Resources around student data privacy, grading practices, assessment, professional learning, and additional content resources to support remote learning.
- <u>Volume 4</u>: Resources for academic intervention support, behavior intervention support as well as additional content resources to support remote learning.

Meal Service:

- Emergency meal service Approximately 4 million meals served
- Pandemic Electronic Benefit Transfer (P-EBT)
 - The P-EBT program provides households with an Electronic Benefit Transfer (EBT) card that contains the value of the free school breakfast and lunch reimbursement rates for the days that schools are closed.
 - The P-EBT program will reach approximately 270,000 children in Connecticut.
 - Benefits are equal to \$5.70 per day per child and will be retroactive to March 17, 2020.
