II. Welcome and Introductions

Ms. Canady welcomed the group and asked members and guests to introduce themselves. She then reviewed the group's engagement norms. Ms. Charlene Russell-Tucker, Deputy Commissioner, Connecticut State Department of Education (CSDE) welcomed the group and introduced the <u>agenda and objectives of the meeting</u>.

III. Emergent Critical Issues in Education

Commissioner Cardona highlighted recent changes to the CSDE organizational structure including the appointment of Ms. Russell-Tucker as Deputy Commissioner of Educational Supports and Wellness, and Mr. Chris Soto as Director of Innovations and Partnerships. He noted that Connecticut schools were recently <u>ranked among the top three in the nation</u> by the independent news organization *Education Week*. The Commissioner said while the national recognition is appreciated, the state has much more to do to provide every student in Connecticut a high quality education and preparation for college and career. One activity he is undertaking toward this end is the creation of a comprehensive plan to promote social and emotional learning, and to improve culture and climate in schools. Commissioner Cardona asked participants to write down their recommendations for this plan; notes were collected and reviewed by the Commissioner.

IV. Pathways to Affordable Post-Secondary Education

Ms. Jeannette Weldon, Executive Director, Connecticut Higher Education Supplemental Loan Authority (CHESLA), introduced CHESLA's mission and vision to expand educational opportunities in Connecticut by offering cost-effective education financing programs and information resources to Connecticut students, alumni and their families. CHESLA is a resource for students as they plan for their college education, not only by providing financing, but also by providing information and tools for students to make informed decisions; to enhance the competitiveness of Connecticut institutions of higher education by providing additional grant and financing options; and to encourage interest in higher education to help the state meet its workforce needs.

Mr. Joshua Hurlock, Assistant Director, CHESLA, presented <u>programs and tools available</u> <u>through CHESLA</u>, including financial literacy and planning tools, a need-based scholarship program, in-school loan program and a program for graduates to refinance college loans.

Ms. Weldon shared the five pillars of CHESLA's strategic plan: collaboration, economic and workforce development for the public good, technology, innovation, and public engagement and accountability. She welcomed members of the Commissioner's Roundtable to collaborate on creating awareness about CHESLA's resources for making post-secondary education affordable for Connecticut students.

Mr. Ajit Gopalakrishnan, Chief Performance Officer, presented on the <u>Free Application for</u> <u>Federal Student Aid (FAFSA)</u>. Mr. Gopalakrishnan noted that completion of the FAFSA is associated with higher rates of college enrollment. Last year, \$17.6 million in federal Pell Grant funding was unclaimed by eligible Connecticut students who did not complete the FAFSA. The CSDE is encouraging school districts to work with high school seniors and their families to complete the FAFSA. CSDE is providing a report on FAFSA Completion Status for currently enrolled Grade 12 students to authorized users in districts through EdSight Secure. Mr. Gopalakrishnan referenced a recent webinar the CSDE created for school districts and other information <u>on the CSDE web</u> <u>site</u>.

V. Roundtable Discussion

Ms. Canady asked participants to work in groups at their tables to consider how they will share the information they received at today's meeting with their constituencies. She also instructed participants to make recommendations for the CSDE to encourage students and families to access financial aid tools, such as the FAFSA and CHESLA. Finally, groups were asked to put forward ideas for developing outreach strategies that could be shared by state and local stakeholders, to promote pathways to affordable post-secondary education.
