II. Welcome and Introductions

Ms. Charlene Russell-Tucker, Chief Operating Officer of the Connecticut State Department of Education, called the group to order and reiterated <u>the charge</u> to the Commissioner's Roundtable for Family and Community Engagement in Education. She thanked the group for their commitment to representing the voices of families and community members in the Roundtable's discussions of important education issues.

Dr. Dianna R. Wentzell, Commissioner of the Connecticut State Department of Education, welcomed the group and thanked them for their commitment and contributions to the Roundtable. Commissioner Wentzell told the group that she intends for the Roundtable to be a durable part of the State Department of Education's work to ensure that parent and community input is not an afterthought.

Ms. Ingrid Canady directed the group's attention to the group norms and reminded them that the norms were co-created with the group using a culturally-responsive process that represented members' interests and values.

III. Important Emergent Issues in Education

- A. Connecticut's Every Student Succeeds Act (ESSA) Consolidated State Plan Ms. Russell-Tucker discussed <u>Connecticut's Every Student Succeeds Act (ESSA)</u> <u>Consolidated State Plan</u>, which was submitted to the U.S. Department of Education on April 3, 2017. Connecticut was among the first group of states to submit a plan. The U.S. Department of Education is expected to finalize the review of Connecticut's plan later this month.
- B. New Guide for Reducing Chronic Absence in Connecticut's Schools
 Ms. Russell-Tucker announced the publication of CSDE's new guide to help schools and districts in their efforts to reduce absenteeism and increase attendance: <u>Reducing Chronic Absence in Connecticut's Schools</u>: A Prevention and Intervention Guide for Schools and <u>Districts</u>. She noted that Connecticut is being recognized as a national leader in this area. The state's chronic absence rate has declined substantially in the last four years, dropping from 11.5 percent in 2012-13 to 9.6 percent in 2015-16

IV. The Connecticut Blueprint for Defining, Understanding and Promoting Family and Community Engagement in Children's Learning and Development

Ms. Russell-Tucker described a new project that CSDE is undertaking in collaboration with the Early Childhood Funders Collaborative, a project of the Connecticut Council for Philanthropy that comprises 14 funders from around the state. The funders are interested in partnering with the CSDE, the Office of Early Childhood and other state agencies to create a clear and useful definition, values and operating principles related to family engagement. Ms. Russell-Tucker noted that the project is responsive to the <u>Connecticut State Board of Education's (CSBE) Five-</u>

<u>Year Comprehensive Plan (2016-21)</u> goal to "support and develop authentic opportunities and experiences for meaningful parental engagement by building capacity for families and school staff to partner effectively in support of student success" (p. 12).

Ms. Russell-Tucker reviewed the project plan and timeline and informed the group that in addition to providing their input in the current meeting, they will be invited to participate in a statewide symposium in the fall (date to be announced). She then introduced guest speaker Anne Henderson, Senior Consultant, National Association for Family, School, and Community Engagement.

Ms. Henderson <u>presented a brief overview of high-impact family engagement strategies</u>. With this backdrop, participants reflected on what makes a good definition of family engagement. Ms. Henderson and Ms. Canady took the group through a facilitated activity to:

- review elements of existing definitions of family engagement;
- discuss and prioritize the elements that they view as most essential and identify important elements that are missing;
- brainstorm ways the definition can be used at the state and local levels; and
- identify tools/materials that will be helpful for implementation.

Ms. Henderson told the group that the notes from their discussion will be compiled to develop a draft definition and as well as sample tools to support implementation. The draft materials will be reviewed at the next meeting Roundtable.

V. Follow-Up from Previous Meeting Regarding the CSBE's Comprehensive Plan Goal for Great Teachers and Leaders

Previous meetings of the Roundtable focused on minority teacher recruitment and the <u>CSBE</u> <u>Five-Year Comprehensive Plan (2016-21)</u> commitment that "great teachers and leaders collectively reflect the rich cultural diversity in Connecticut and are culturally responsive educators" (page 5). At the April 20, 2017 meeting members were asked to provide input on behalf of their organization related to increasing the cultural diversity and responsiveness of Connecticut's educators. Ms. Russell-Tucker thanked members for providing input. She noted that CSDE received input from 10 members and other members who would like to respond should do so before the end of the month. Members' feedback will be compiled for the Commissioner's consideration.

VI. Meeting Dates for 2017-18

The Roundtable will continue to meet regularly. Meeting dates for the 2017-18 school year are September 27, 2017; January 24, 2018; and May 9, 2018. All meetings will take place from 9:00 a.m. to 11:30 a.m. (locations to be determined). The topic of the September 27, 2017 meeting will be Connecticut's Next Generation Accountability System.

VII. Adjournment

The meeting was adjourned at 12:00 p.m.
