II. Welcome and Introductions

Mr. John Frassinelli, Division Director, Connecticut State Department of Education (CSDE), welcomed the group and reviewed the <u>agenda and objectives of the meeting</u>. He introduced Acting Commissioner Russell-Tucker.

III. Emergent Critical Issues in Education

Acting Commissioner Russell-Tucker noted that there are a number of new and important initiatives taking place. She invited members of the meeting to share this information with their constituents.

Commissioner Russell-Tucker presented the following emergent issues:

- The CSDE awarded funding for high-quality summer enrichment programs to 235 applicants through the AccelerateCT Summer Program Expansion Grant, which is funded by the federal American Rescue Plan (ARP) Act, 2021, Elementary and Secondary School Emergency Relief Fund (ESSER). Over 96,000 Connecticut children will be served by programs throughout the state. Families can find <u>information</u> about hundreds of summer programs that are offered through municipalities, school districts, and community partners such as non-profits, childcare centers, private and independent schools, and faith-based organizations.
- Governor Lamont initiated a program to allow Connecticut children 18 and under, plus one accompanying adult, to visit any of the state's participating museums, zoos, science and cultural centers. The program will be created with ARP ESSER funding and the full list of participation attractions will be available at <u>www.ctvisit.com</u> by July 1, 2021.
- Commissioner Russell-Tucker introduced Ms. Tanya Budler, Office of the Governor, who discussed <u>Connecticut's state plan</u> for the ARP ESSER funds. Her <u>presentation</u> highlighted the state's priorities and the amounts of funding available for school districts and for state-level activities.
- The CSDE, in collaboration with SERC, held two public forums to engage diverse stakeholder groups in developing Connecticut's ARP ESSER state plan. Members in the public forums provided input utilizing the structure of the <u>CSDE Public and Stakeholder</u> <u>Input document</u>. Videos of those sessions are available on <u>the CSDE website</u>.
- Mr. Frassinelli reviewed a new initiative for reengaging chronically absent students and improving attendance. <u>The Learner Engagement and Attendance Program (LEAP)</u> was created by the Governor's Office to target 15 high-need districts. The program will support home visits with the goal of reengaging students, encouraging them to participate in summer programs and facilitating a seamless reentry into school in the fall.
- Mr. Desi Nesmith, Deputy Commissioner, discussed new online curricula that are available in Connecticut. In May, the CSDE <u>announced</u> that it is entering into partnerships with Apex Learning and Defined Learning to provide equitable access to high-quality online curricula and courses for students and teachers, at no cost to school districts. The partnerships are part of CSDE's <u>efforts</u> to advance state-level priorities for use of the ARP ESSER funding, including the strategic use of technology to engage and

expand equitable access to high-impact, accelerated learning opportunities. Mr. Nesmith said that, through this project and others, the CSDE is working with districts to prioritize equity and language access for all students.

• Over the last five years, school districts in Connecticut have hired more than 1,900 educators of color, exceeding the goal set by the State Board of Education to increase the number of educators of color by 10 percent – approximately 1,000 positions – between 2017 and 2021. Commissioner Russell-Tucker noted that, while the five-year goal has been met, the CSDE would continue pursuing policies that do more to close the existing gap between educators and students of color.

IV. Panel Discussion: Engaging Stakeholders in Connecticut's American Rescue Plan Act of 2021 Elementary and Secondary School Emergency Relief Funds (ARP ESSER) Mr. Frassinelli introduced panel members: Milly Arciniegas, Executive Director, Hartford Parent University; Andreas Lolis, Student, State Student Advisory Council on Education; Gwen Samuel, Founder and President, CT Parents Union; and Mirellise Vazquez, Executive Director, Tauck Family Foundation.

The panel considered two questions:

- How can the CSDE best communicate with families about ARP ESSER and other education-related initiatives and encourage their input/participation?
- What can the CSDE communicate with districts as practical approaches to engage and communicate with families and communities about ARP ESSER planning and opportunities?

The panel discussed issues related to ensuring families and community members are meaningful participants in planning for use of federal funds. The discussion included strategies for improving two-way communication between schools and families, utilizing community partners and grass roots efforts to be more inclusive of families who do not speak English, and partnering with philanthropy for assistance with engaging and convening families and community members.

V. Listening to Roundtable Members: Observations and Recommendations

Ms. Canady invited participants to share their perspectives regarding the panel discussion. Participants were also invited to submit their suggestions and questions about state and local planning and use of ARP ESSER funds and returning to school in September. Commissioner Russell-Tucker discussed the importance of identifying effective uses of the new funding and strategies for sustainability. She expressed her appreciation for the contributions of Roundtable members as continuing partners in this work.

VI. Adjournment

The meeting was adjourned at 2:30 p.m.
