II. Welcome and Introductions

Ms. Ingrid Canady, Executive Director, State Education Resource Center (SERC) welcomed the group and asked members and guests to introduce themselves. Ms. Canady then reviewed the group's engagement norms.

III. Emergent Critical Issues in Education

Ms. Russell-Tucker, Chief Operating Officer of the Connecticut State Department of Education (CSDE) provided information on the following issues:

• CSDE recently won a federal five-year grant called Project AWARE (Advancing Wellness and Resiliency in Education). The state will receive \$1.8 million over five years to increase awareness of mental health issues among school-age youth and to provide training for school personnel and other adults.

- CSDE's "Evidence-Based Practice Guides" are available on the agency's Web site.
 The guides are intended to inform school and district decision-making regarding
 instructional and student support programming and to optimize the use of local, state,
 and federal school improvement funds. A guide is available for school-familycommunity partnerships as well as six other areas that address academics and school
 culture.
- CSDE recently released a new publication entitled "<u>Alternative Educational</u>
 Opportunities for Students Who Have Been Expelled: Best Practice Guidelines for
 <u>Program Implementation.</u>" These Best Practice Guidelines provide a framework to
 support the implementation of high-quality programming for students placed in an
 existing alternative program or school or a different alternative educational
 opportunity.
- CSDE is launching the CT School Discipline Collaborative on October 31, 2018.
 The purpose of the group is to advise the Commissioner and the State Board of
 Education on strategies for transforming school discipline in order to reduce the
 overall disproportionate use of exclusionary discipline.
- CSDE conducted a brief survey of superintendents to gain an understanding of the
 use of evidence-based family engagement strategies in school districts. The CSDE
 will provide information to superintendents throughout the school year to support
 implementation of high-impact family engagement aligned with the <u>Evidence-Based</u>
 <u>Practice Guide</u>.
- The <u>Commissioner's 2018-19 Back-to-School Meeting</u> took place on August 15, 2018 and included <u>information about Connecticut's new definition of family engagement.</u>
- Recent results for the Advanced Placement (AP) exams show that Connecticut public school students are continuing to increase their performance and participation. The number of students who took at least one AP exam in 2017-18 increased 5 percent over 2016-17. Of the exams taken, the number of students achieving a score of three, four, or five increased 3.8 percent over 2016-17. These improvements were evidenced among students from all racial/ethnic backgrounds and extend to the state's Alliance Districts.
- Mr. John Frassinelli, Chief, Bureau of Health/Nutrition, Family Services and Adult Education, discussed the Safe Havens Act for Newborns, which creates a safe alternative to leaving or abandoning unwanted infants in unsafe places. The Act allows a parent to voluntarily give up custody of an infant 30 days or younger and avoid prosecution for abandonment by bringing the infant to one of the state's 37 hospital emergency rooms. The law went into effect in Connecticut in 2000 and has since saved the lives of 37 infants. IV. Connecticut's New Definition and Framework for Family Engagement: Presentation and Call to Action

Dr. Judy Carson, Program Manager for School-Family-Community Partnerships, CSDE, provided an overview of "Full, Equal and Equitable Partnerships with Families: Connecticut's <u>Definition and Framework for Family Engagement.</u>" highlighting the definition, guiding principles, stakeholders roles and actions, and examples of high-impact practice.

The project was a joint effort with CT Office of Early Childhood (OEC) and the Early Childhood Funders Collaborative and represents a birth to college and career approach. Guest speakers described how the definition and framework are informing work in their agency/organization.

- Ms. Jennifer Johnson, Division Director, OEC, discussed how the OEC's family engagement activities align with the new definition and framework (particularly the Quality Recognition and Improvement System).
- Ms. Elena Trueworthy, Associate Director, Early Childhood Collaborative, Hartford Foundation for Public Giving, described how the definition and framework provide a common language that will help funders avoid working in silos.
- Ms. Jennifer Michno, Clinical Instructor, Neag School of Education, University of Connecticut, discussed a partnership between the University and the Hartford Foundation for Public Giving to effectively implement family, school and community engagement work into leadership training for aspiring administrators. Five training modules were developed and piloted with students this fall.

Ms. Canady facilitated a discussion with participants about actions they can take to implement the framework in their own work. Participants talked about actions they can take individually and ways they can promote systems change.

Dr. Dianna Wentzell thanked the group for their participation and recommendations. She underscored the importance of the group as a permanent part of the CSDE's structure for advising the Commissioner's office on policy matters.

SUBJECT: Connecticut Safe Havens Act for Newborns

In Connecticut, the Safe Havens Act for Newborns, codified in Connecticut General Statutes (C.G.S.) Sections 17a-57 to 17a-61, creates a safe alternative to leaving or abandoning unwanted infants in unsafe places. The Act allows a parent to voluntarily give up custody of an infant 30 days or younger and avoid prosecution for abandonment by bringing the infant to one of the state's 37 hospital emergency rooms. The law went into effect in Connecticut in 2000 and has since saved the lives of 37 infants, according to data from the Connecticut Department of Children and Families (DCF). The Connecticut Safe Havens Act statutes can be found at https://www.cga.ct.gov/current/pub/chap_319.htm#sec_17a-57.

Section 2 of Public Act 18-182 requires the Connecticut State Board of Education (SBE) to provide local and regional boards of education with information on Connecticut's Safe Havens Act and how instructional materials can be obtained from DCF. In an effort to save the lives of additional infants, the Connecticut State Department of Education (CSDE) encourages districts to provide instruction to students regarding Connecticut's Safe Havens Act as part of the high school curriculum. The slogan from proponents of the legislation supporting this instruction is: "10 Minutes in 10th Grade."
