Emergency Declarations

After his March 10, 2020 declaration of public health and civil preparedness emergencies, the Governor has issued a series of Executive Orders as a result of the coronavirus disease 2019 (COVID-19) outbreak in the United States.



Executive Order 7

• March 12, 2020

 Initial order limiting gatherings (250 people) and beginning to address public health and safety concerns

Executive Order 7A

• March 13, 2020

 Authorized the Commissioner of Public Health to restrict entrance into nursing homes and similar facilities to protect vulnerable populations

Executive Order 7B

• March 14, 2020

- Modified public meetings requirements
- Began addressing shortage of hand sanitizer and personal protective equipment (PPE)
- Allowed for more flexibility to increase the availability of childcare

Executive Order 7C

• March 15, 2020

- Cancelled classes in public schools for at least two weeks
- Authorized Commissioner of Education to exercise flexibility under certain statutes to address class cancelation impact
- Extended deadlines for municipal and regional board of education budget preparations

Executive Order 7D

• March 16, 2020

- Restricted social and recreational gatherings of all types to fewer than 50 people
- Closed many recreational facilities and limited restaurants to take-out

Executive Order 7E

• March 17, 2020

 Addressed evolving circumstances suggesting a longer term school class cancelation by clarifying the waiver of the requirement for 180 day school year, allowing all districts to close on their normally scheduled end-date, so long as they provide continued educational opportunities to the greatest extent possible

Executive Order 7F

• March 18, 2020

- Ordered the closure of shopping malls, places of public amusement except public parks and open recreation areas
- Expanded Medicaid telehealth coverage,
- Clarified the order cancelling school classes related to USD1 and USD2

Executive Order 7G

• March 19, 2020

- Postponed the presidential primary
- Suspended court operations
- Expanded the availability of telehealth services

Executive Order 7H

• March 20, 2020

- "Stay Safe, Stay Home" initiative Limited the workplace operations of non-essential businesses, and non-profits
- Not directly applicable to boards of education

Executive Order 7I

• March 21, 2020

- Authorized Commissioner of Education to allow flexibility related to the Student Data Privacy Act
- Allowed restrictions on DCF visitation
- Provided some procedural relief for municipalities and regional boards of education

Executive Order 7I (con'd)

Executive Order 7J

• March 22, 2020

- Expanded the availability of temporary retired workers to fill critical staffing needs
- Clarified restrictions on the operations of nonessential businesses

Executive Order 7K

• March 23, 2020

- Suspended additional court and administrative proceedings
- Authorized remote notarization

Executive Order 7L

• March 24, 2020

 Extended the cancellation of public school classes through April 20, 2020, unless further extended

Executive Order 7M

• March 25, 2020

 Authorized commissioners of state agencies to suspend or modify administrative deadlines

Executive Order 7N

- March 26, 2020
- Further limited social and recreational gatherings to 5 people
- Suspended school testing assessments for 2019-20 school year
- Further restricted restaurant and retail operations
- Suspended 21-month limit on Temporary Family Assistance

Executive Order 70

• March 27, 2020

• Waived of Birth-to-Three family cost participation fees

Executive Order 7P

• March 28, 2020

 Authorized provision of non-congregant housing for persons at risk

Executive Order 7Q

• March 30, 2020

- Limited group sizes in childcare
- Increased health procedures for all operating childcare programs

Executive Order 7R

• March 31, 2020

- Addressed funding for boards of education; continuation of payment of public school staff
- Required preservation of student transportation services and special education providers

Executive Order 7S

• April 1, 2020

- Allowing grace period for premium payments, policy cancellations, and non-renewals of insurance policies
- Provided relief from certain municipal tax deadlines and collection efforts
