Count to 100 by ones and by tens.

## Counting and Cardinality

Know number names and the count sequence.

## K.CC.A. 3

Write numbers from 0 to 20. Represent a number of objects with a written numeral 0-20 (with 0 representing a count of no objects).

## Counting and Cardinality

Know number names and the count sequence.

## K.CC.A. 2

Count forward beginning from a given number within the known sequence (instead of having to begin at 1).

## Counting and Cardinality

Count to tell the number of objects.

## K.CC.B. 4

Understand the relationship between numbers and quantities; connect counting to cardinality.

Count to tell the number of objects.

## K.CC.B.4a

When counting objects, say the number names in the standard order, pairing each object with one and only one number name and each number name with one and only one object.

## 1.OA.A. 1

Use addition and subtraction within 20 to solve word problems involving situations of adding to, taking from, putting together, taking apart, and comparing, with unknowns in all positions, e.g., by using objects, drawings, and equations with a symbol for the unknown number to represent the problem*.

## Represent and solve problems

 involving addition and subtraction.
## 1.OA.A. 2

Solve word problems that call for addition of three whole numbers whose sum is less than or equal to 20 , e.g., by using objects, drawings, and equations with a symbol for the unknown number to represent the problem.

Understand and apply properties of operations and the relationship between addition and subtraction.

## 1.OA.B. 3

Apply properties of operations as strategies to add and subtract.* Examples: If $8+3=11$ is known, then 3 $+8=11$ is also known. (Commutative property of addition.) To add $2+6+4$, the second two numbers can be added to make a ten, so $2+6+4=2+$ $10=12$. (Associative property of addition.)

Understand and apply properties of operations and the relationship between addition and subtraction.

## 1.OA.B. 4

Understand subtraction as an unknown-addend problem. For example, subtract $10-8$ by finding the number that makes 10 when added to 8.

## 1.OA.C. 5

Relate counting to addition and subtraction (e.g., by counting on 2 to add 2).

Add and subtract within 20.
1.OA.C. 6

Add and subtract within 20, demonstrating fluency for addition and subtraction within 10 . Use strategies such as counting on; making ten (e.g., $8+6=8+2+4=10$ $+4=14$ ); decomposing a number leading to a ten (e.g., 13-4=13-3-$1=10-1=9$ ); using the relationship between addition and subtraction (e.g., knowing that $8+4=12$, one knows 12-8=4); and creating equivalent but easier or known sums (e.g., adding $6+7$ by creating the known equivalent $6+6+1=12+1=$ 13).

## 1.OA.D. 8

Determine the unknown whole number in an addition or subtraction equation relating three whole numbers. For example, determine the unknown number that makes the equation true in each of the equations $8+$ ? $=11,5=\_-3,6+6=$

## Work with addition and subtraction equations.

## 1.OA.D. 7

Understand the meaning of the equal sign, and determine if equations involving addition and subtraction are true or false. For example, which of the following equations are true and which are false? $6=6,7=8-1,5+2=2+5$, $4+1=5+2$.

Represent and solve problems involving addition and subtraction.

## 2.OA.A. 1

Use addition and subtraction within 100 to solve one- and two-step word problems involving situations of adding to, taking from, putting together, taking apart, and comparing, with unknowns in all positions, e.g., by using drawings and equations with a symbol for the unknown number to represent the problem*.

Add and subtract within 20.

## 2.OA.B. 2

Fluently add and subtract within 20 using mental strategies*. By end of Grade 2, know from memory all sums of two one-digit numbers.

Operations and Algebraic Thinking
Work with equal groups of objects to gain foundations for multiplication.

## 2.OA.C. 4

Use addition to find the total number of objects arranged in rectangular arrays with up to 5 rows and up to 5 columns; write an equation to express the total as a sum of equal addends.

Work with equal groups of objects to gain foundations for multiplication.

## 2.OA.C. 3

Determine whether a group of objects (up to 20) has an odd or even number of members, e.g., by pairing objects or counting them by 2 s ; write an equation to express an even number as a sum of two equal addends.

Operations and Algebraic Thinking
Represent and solve problems involving multiplication and division.

## 3.OA.A. 1

Interpret products of whole numbers, e.g., interpret $5 \times 7$ as the total number of objects in 5 groups of 7 objects each. For example, describe a context in which a total number of objects can be expressed as $5 \times 7$.

## 3.OA.A. 2

Interpret whole-number quotients of whole numbers, e.g., interpret $56 \div 8$ as the number of objects in each share when 56 objects are partitioned equally into 8 shares, or as a number of shares when 56 objects are partitioned into equal shares of 8 objects each. For example, describe a context in which a number of shares or a number of groups can be expressed as $56 \div 8$.

## Represent and solve problems involving multiplication and division.

## 3.OA.A. 3

Use multiplication and division within 100 to solve word problems in situations involving equal groups, arrays, and measurement quantities, e.g., by using drawings and equations with a symbol for the unknown number to represent the problem*.

## Operations and Algebraic Thinking

Understand properties of multiplication and the relationship between multiplication and division.

## 3.OA.B. 5

Apply properties of operations as strategies to multiply and divide*. Examples: If $6 \times 4=24$ is known, then 4 $\times 6=24$ is also known. (Commutative property of multiplication.) $3 \times 5 \times 2$ can be found by $3 \times 5=15$, then $15 \times 2$ $=30$, or by $5 \times 2=10$, then $3 \times 10=30$. (Associative property of multiplication.) Knowing that $8 \times 5=40$ and $8 \times 2=16$, one can find $8 \times 7$ as $8 \times(5+2)=(8 \times$ 5) $+(8 \times 2)=40+16=56$. (Distributive property.)

Understand properties of multiplication and the relationship between multiplication and division.

## 3.OA.B. 6

Understand division as an unknownfactor problem. For example, find $32 \div$ 8 by finding the number that makes 32 when multiplied by 8.

Multiply and divide within 100.

## 3.OA.C. 7

Fluently multiply and divide within 100 using strategies such as the relationship between multiplication and division (e.g., knowing that $8 \times 5=40$, one knows $40 \div 5=8$ ) or properties of operations. By the end of Grade 3, know from memory all products of two one-digit numbers.

Solve problems involving the four operations, and identify and explain patterns in arithmetic.

## 4.OA.A. 1

Interpret a multiplication equation as a comparison, e.g., interpret $35=5 \times 7$ as a statement that 35 is 5 times as many as 7 and 7 times as many as 5 . Represent verbal statements of multiplicative comparisons as multiplication equations.

## Use the four operations with whole numbers to solve problems.

## 4.OA.A. 2

Multiply or divide to solve word problems involving multiplicative comparison, e.g., by using drawings and equations with a symbol for the unknown number to represent the problem, distinguishing multiplicative comparison from additive comparison*.

## Operations and Algebraic Thinking

Use the four operations with whole numbers to solve problems.

## 4.OA.A. 3

Solve multistep word problems posed with whole numbers and having wholenumber answers using the four operations, including problems in which remainders must be interpreted. Represent these problems using equations with a letter standing for the unknown quantity. Assess the reasonableness of answers using mental computation and estimation strategies including rounding.

Gain familiarity with factors and multiples.

## 4.OA.B. 4

Find all factor pairs for a whole number in the range $1-100$. Recognize that a whole number is a multiple of each of its factors. Determine whether a given whole number in the range $1-100$ is a multiple of a given one-digit number. Determine whether a given whole number in the range 1-100 is prime or composite.

## 4.OA.C. 5

Generate a number or shape pattern that follows a given rule. Identify apparent features of the pattern that were not explicit in the rule itself. For example, given the rule "Add 3" and the starting number 1 , generate terms in the resulting sequence and observe that the terms appear to alternate between odd and even numbers.
Explain informally why the numbers will continue to alternate in this way.

## Operations and Algebraic Thinking

Write and interpret numerical expressions.

## 5.OA.A. 2

Write simple expressions that record calculations with numbers, and interpret numerical expressions without evaluating them. For example, express the calculation "add 8 and 7 , then multiply by 2 " as $2 \times(8+7)$. Recognize that $3 \times(18932+921)$ is three times as large as $18932+921$, without having to calculate the indicated sum or product.

## 5.OA.A. 1

Use parentheses, brackets, or braces in numerical expressions, and evaluate expressions with these symbols.

Operations and Algebraic Thinking
Analyze patterns and relationships.

## 5.OA.B. 3

Generate two numerical patterns using two given rules. Identify apparent relationships between corresponding terms. Form ordered pairs consisting of corresponding terms from the two patterns, and graph the ordered pairs on a coordinate plane. For example, given the rule "Add 3 " and the starting number 0 , and given the rule "Add 6 " and the starting number 0 , generate terms in the resulting sequences, and observe that the terms in one sequence are twice the corresponding terms in the other sequence. Explain informally why this is so.

Work with numbers 11-19 to gain foundations for place value.

## K.NBT.A. 1

Compose and decompose numbers from 11 to 19 into ten ones and some further ones, e.g., by using objects or drawings, and record each composition or decomposition by a drawing or equation (such as $18=10+$ 8); understand that these numbers are composed of ten ones and one, two, three, four, five, six, seven, eight, or nine ones.

Understand place value.

## 1.NBT.B. 2

Understand that the two digits of a twodigit number represent amounts of tens and ones. Understand the following as special cases:

- 1.NBT.B.2a 10 can be thought of as a bundle of ten ones - called a "ten."
- 1.NBT.B.2b The numbers from 11 to 19 are composed of a ten and one, two, three, four, five, six, seven, eight, or nine ones.
- 1.NBT.B.2c The numbers 10, 20,30, 40, 50, 60, 70, 80, 90 refer to one, two, three, four, five, six, seven, eight, or nine tens (and 0 ones).


## 1.NBT.A. 1

Count to 120 , starting at any number less than 120. In this range, read and write numerals and represent a number of objects with a written numeral.

## Number and Operations in Base Ten

Understand place value.

## 1.NBT.B. 3

Compare two two-digit numbers based on meanings of the tens and ones digits, recording the results of comparisons with the symbols $>,=$, and <.

Use place value understanding and properties of operations to add and subtract.

## 1.NBT.C. 4

Add within 100, including adding a two-digit number and a one-digit number, and adding a two-digit number and a multiple of 10, using concrete models or drawings and strategies based on place value, properties of operations, and/or the relationship between addition and subtraction; relate the strategy to a written method and explain the reasoning used. Understand that in adding two-digit numbers, one adds tens and tens, ones and ones; and sometimes it is necessary to compose a ten.

## Number and Operations in Base Ten

Use place value understanding and properties of operations to add and subtract.
1.NBT.C. 6

Subtract multiples of 10 in the range 10-90 from multiples of 10 in the range 10-90 (positive or zero differences), using concrete models or drawings and strategies based on place value, properties of operations, and/or the relationship between addition and subtraction; relate the strategy to a written method and explain the reasoning used.

Use place value understanding and properties of operations to add and subtract.
1.NBT.C. 5

Given a two-digit number, mentally find 10 more or 10 less than the number, without having to count; explain the reasoning used.

## Number and Operations in Base Ten

Understand place value.
2.NBT.A. 1

Understand that the three digits of a three-digit number represent amounts of hundreds, tens, and ones; e.g., 706 equals 7 hundreds, 0 tens, and 6 ones. Understand the following as special cases:

- 2.NBT.A.1a 100 can be thought of as a bundle of ten tens called a "hundred."
- 2.NBT.A.1b The numbers 100, 200, $300,400,500,600,700,800,900$ refer to one, two, three, four, five, six, seven, eight, or nine hundreds (and 0 tens and 0 ones).

Count within 1000; skip-count by 5s, 10 s, and 100 s .

Fluently add and subtract within 100 using strategies based on place value, properties of operations, and/or the relationship between addition and subtraction.

## 2.NBT.B. 6

Add up to four two-digit numbers using strategies based on place value and properties of operations.

Use place value understanding and properties of operations to add and subtract.

## 2.NBT.B. 7

Add and subtract within 1000, using concrete models or drawings and strategies based on place value, properties of operations, and/or the relationship between addition and subtraction; relate the strategy to a written method. Understand that in adding or subtracting three-digit numbers, one adds or subtracts hundreds and hundreds, tens and tens, ones and ones; and sometimes it is necessary to compose or decompose tens or hundreds.

## 3.NBT.A. 2

Fluently add and subtract within 1000 using strategies and algorithms based on place value, properties of operations, and/or the relationship between addition and subtraction.

## 3.NBT.A. 3

Multiply one-digit whole numbers by multiples of 10 in the range 10-90 (e.g., $9 \times 80,5 \times 60$ ) using strategies based on place value and properties of operations.

## 4.NBT.A. 1

Recognize that in a multi-digit whole number, a digit in one place represents ten times what it represents in the place to its right. For example, recognize that $700 \div 70=10$ by applying concepts of place value and division.

## 4.NBT.A. 2

Read and write multi-digit whole numbers using base-ten numerals, number names, and expanded form. Compare two multi-digit numbers based on meanings of the digits in each place, using >, $=$, and < symbols to record the results of comparisons.

Multiply a whole number of up to four digits by a one-digit whole number, and multiply two two-digit numbers, using strategies based on place value and the properties of operations. Illustrate and explain the calculation by using equations, rectangular arrays, and/or area models.

## 4.NBT.B. 6

Find whole-number quotients and remainders with up to four-digit dividends and one-digit divisors, using strategies based on place value, the properties of operations, and/or the relationship between multiplication and division. lllustrate and explain the calculation by using equations, rectangular arrays, and/or area models.

## 5.NBT.A. 2

Explain patterns in the number of zeros of the product when multiplying a number by powers of 10 , and explain patterns in the placement of the decimal point when a decimal is multiplied or divided by a power of 10 . Use whole-number exponents to denote powers of 10 .

## 5.NBT.A. 1

Recognize that in a multi-digit number, a digit in one place represents 10 times as much as it represents in the place to its right and $1 / 10$ of what it represents in the place to its left.

## 5.NBT.A. 3

Read, write, and compare decimals to thousandths.

- 5.NBT.A.3a Read and write decimals to thousandths using base-ten numerals, number names, and expanded form, e.g., $347.392=3 \times 100+4 \times 10+$ $7 \times 1+3 \times(1 / 10)+9 \times(1 / 100)+2$ $\times(1 / 1000)$.
- 5.NBT.A.3b Compare two decimals to thousandths based on meanings of the digits in each place, using >, =, and < symbols to record the results of comparisons.

## 5.NBT.A. 4

Use place value understanding to round decimals to any place.

5.NBT.B. 5

Perform operations with multi-digit whole numbers and with decimals to hundredths.

## 5.NBT.B. 7

Add, subtract, multiply, and divide decimals to hundredths, using concrete models or drawings and strategies based on place value, properties of operations, and/or the relationship between addition and subtraction; relate the strategy to a written method and explain the reasoning used.

Develop understanding of fractions as numbers*.

## 3.NF.A. 1

Understand a fraction $1 / b$ as the quantity formed by 1 part when a whole is partitioned into b equal parts; understand a fraction $a / b$ as the quantity formed by a parts of size $1 / b$.

Develop understanding of fractions as numbers.

## 3.NF.A.2a

Represent a fraction $1 / b$ on a number line diagram by defining the interval from 0 to 1 as the whole and partitioning it into $b$ equal parts.
Recognize that each part has size $1 / b$ and that the endpoint of the part based at 0 locates the number $1 / b$ on the number line.

Develop understanding of fractions as numbers.

## 3.NF.A. 2

Understand a fraction as a number on the number line; represent fractions on a number line diagram.

## Number and Operations - Fractions

Develop understanding of fractions as numbers.
3.NF.A.2b

Represent a fraction a/b on a number line diagram by marking off a lengths 1/b from 0 . Recognize that the resulting interval has size $a / b$ and that its endpoint locates the number $a / b$ on the number line.

Develop understanding of fractions as numbers.

## 3.NF.A. 3

Explain equivalence of fractions in special cases, and compare fractions by reasoning about their size.

## Number and Operations - Fractions

Develop understanding of fractions as numbers.

## 3.NF.A.3b

Recognize and generate simple equivalent fractions, e.g., $1 / 2=2 / 4$, $4 / 6=2 / 3$. Explain why the fractions are equivalent, e.g., by using a visual fraction model.

Develop understanding of fractions as numbers.

## 3.NF.A.3a

Understand two fractions as equivalent (equal) if they are the same size, or the same point on a number line.

Number and Operations - Fractions
Develop understanding of fractions as numbers.
3.NF.A.3c

Express whole numbers as fractions, and recognize fractions that are equivalent to whole numbers.
Examples: Express 3 in the form $3=3 / 1$; recognize that $6 / 1=6$; locate $4 / 4$ and 1 at the same point of a number line diagram.

Develop understanding of fractions as numbers.

## 3.NF.A.3d

Compare two fractions with the same numerator or the same denominator by reasoning about their size.
Recognize that comparisons are valid only when the two fractions refer to the same whole. Record the results of comparisons with the symbols $>,=$, or <, and justify the conclusions, e.g., by using a visual fraction model.

For example, interpret 3/4 as the result of dividing 3 by 4 , noting that $3 / 4$ multiplied by 4 equals 3 , and that when 3 wholes are shared equally among 4 people each person has a share of size $3 / 4$. If 9 people want to share a 50-pound sack of rice equally by weight, how many pounds of rice should each person get? Between what two whole numbers does your answer lie?

Apply the formulas $V=1 \times w \times h$ and $V$ $=b \times h$ for rectangular prisms to find volumes of right rectangular prisms with whole-number edge lengths in the context of solving real world and mathematical problems.

Find the volume of a right rectangular prism with whole-number side lengths by packing it with unit cubes, and show that the volume is the same as would be found by multiplying the edge lengths, equivalently by multiplying the height by the area of the base. Represent threefold wholenumber products as volumes, e.g., to represent the associative property of multiplication.

Recognize volume as additive. Find volumes of solid figures composed of two non-overlapping right rectangular prisms by adding the volumes of the non-overlapping parts, applying this technique to solve real world problems.
