<ul style="list-style-type: none"> *Relating structures at school level--unknown outside entities and what they do/how they're important as a whole/individual *Responsibility-What is means to them personally and as a whole based on the text. *"Importance" as a vocabulary term to explore-What does it mean to be "important"? Why are these people "important"? *Discuss cause and effect. 			
Big Takeaway			
<p>At the second grade level, we would focus on how everyone has different jobs and responsibilities that affect others in our daily lives. We would explore how these responsibilities affect others if they chose to neglect their responsibilities? (Making inferences)</p> <p>Everyone has an "important" responsibility.
