New Social Studies Framework

Written by a team of Connecticut social studies educators consisting of elementary, middle and high school, as well as higher education faculty from Connecticut's rural, suburban and urban districts, the Connecticut Elementary and Secondary Social Studies Frameworks for Grades K-12 is based on the national College, Career and Civic Life (C3) Framework for Social Studies State Standards.

Many social studies educators find this to be an exciting and empowering instructional tool for use with their students. Using an inquiry-based approach to social studies, instruction is based on both teachers and students asking and answering compelling questions. Through the lenses of civics, U.S. and world history, economics and geography, the framework asks students "to do," not only by communicating conclusions in essays and presentations for the classroom or the teacher, but also to take informed action within the school, local, state and national community. This framework presents a new way of

teaching social studies by advocating that students "take informed action" and become active and engaged citizens.

While the Board of Education gave initial approval, these frameworks will be brought to the February 2015 State Board of Education meeting for final approval. The CT Core Standards Web site also provides a listing of professional development opportunities, access to a library of professional learning materials, and on-demand professional learning through webinars and video resources. #### Smarter Balanced Digital Library



The Smarter Balanced Assessment Consortium is committed to ensuring that all students leave high school prepared for postsecondary success in college or careers. A balanced assessment system – which includes *summative* and *interim* assessments and *formative* assessment practices – provides tools to improve teaching and learning. The formative assessment process is an essential component of a balanced assessment system.

More than 1,300 educators from 22 states (64 from Connecticut) with diverse areas of expertise have been populating the Smarter Balanced Digital Library with professional learning and instructional resources. All resources are vetted by educators using quality criteria before being posted in the Digital Library.

The Digital Library is a searchable, interactive, online collection of instructional and professional learning resources for all content areas developed by educators for all K-12 educators. Currently, there are over 2,500 resources posted in the Digital Library. These resources are aligned

with the intent of the Common Core State Standards and will help educators implement the formative assessment process to adjust teaching to improve student learning. Resources include lesson plans, units, rubrics, instructional strategies, videos of educators in action and professional learning materials. The Digital Library will also include resources to interpret data and reports from the Smarter Balanced summative and interim assessments. This interactive site includes collaborative features that allow educators to rate resources, pose questions and share expertise through online forums with other educators across Consortium states.

The Digital Library uses state-of-the-art tagging, filtering and search features to locate, view, download and rate resources. Users just need to click on one of thousands of resources at any grade level and any content area to read and then download for immediate use!

### Integrating Arts Between School and Community

Over eighty grant applications were submitted this past October seeking monies from a pool of \$250,000.00 for the Arts in Education Mini-Grant program. With the support from the Connecticut Association of Schools (CAS), selected panelists representing the CSDE, CAS and the Department of Economic and Community Development's (DECD), Connecticut Office of the Arts (COA) convened and reviewed these grant applications.

The grant award winners were publicly announced on December 18 during a gathering at the Long Wharf Theatre. Applicants identified the ways in which their proposed art programs would support collaboration between art and content domain teachers. Typically, proposals embedded the arts across content areas and included partnerships with other practitioners (i.e., artists, local museums) and the larger external community. #### **Professional Learning Opportunities**

The CSDE sponsors a variety of professional learning opportunities for teachers, school principals, instructional coaches and professors of higher education. If you would like to expand your knowledge of the CT Core Standards, gain a better understanding for how aligned instruction and student learning can be enhanced or take advantage of high-quality resources and programs, consider attending one or more sessions described below:

Beginning in January 2015, Public Consulting Group (PCG), in partnership with the CSDE, will present **Meeting the Challenge: CT Core Standards Success for English** Learners and Students with Disabilities. This is a three-module series for school teams who create inclusive environments and share instruction of English Learners (ELs) and students with disabilities. Our goal is to empower educators to implement the CT



Core Standards aligned curriculum, instructional practices and assessments to meet the needs of a wide variety of learners. PCG's national experts in Special Education and English as a Second Language have designed a series of three professional learning modules for school teams consisting of one (1) principal (or other school leader, one (1) special educator serving students with disabilities, one (1) TESOL educator serving English learners and two (2) general education educators.
