SUBJECT: Preventing Youth Suicide in Connecticut

Tragically, Connecticut has already lost five students to suicide in 2025. The passing of these students is being mourned by countless classmates, educators, friends, and family members, not only in their own communities but across the state. In the 2023 Connecticut School Health Survey (i.e. Youth Risk Behavior Survey), of the 3,182 high school students who completed the survey, 15.7 percent reported that they seriously considered attempting suicide and 7.7 percent reported that they had actually attempted suicide within the last twelve months. These percentages are an increase from 14.1 percent and 5.9 percent respectfully, as reported in the 2021 Connecticut School Health Survey. The Connecticut State Department of Education (CSDE) provides the following information and resources to assist districts in supporting the important role of schools in youth suicide prevention.

Connecticut is fortunate to have five <u>Regional Suicide Advisory Boards</u> (RSAB) which operate as part of the <u>Regional Behavioral Health Action Organization</u> (RBHAO) to support the <u>CT Strategic Plan for Suicide Prevention</u> by providing training and evidence-based guidance for mental health promotion including suicide prevention, intervention and response. The local RSAB's are available to partner with schools to strengthen the foundational knowledge for students and staff for suicide warning signs, intervention strategies, and postvention best-practices.

To further enhance schools' capacity to support youth suicide prevention the CSDE, in collaboration with the Department of Children and Families (DCF) and the Department of Mental Health and Addiction Services (DMHAS), hosted a webinar on February 27, 2025, for school mental health staff and other school professionals dedicated to youth suicide prevention.

As part of this fall's *Virtual House Call Series: Supporting Your Child's Health and Wellbeing During the School Year*, CSDE hosted a panel of experts from DCF and DHMAS to discuss warning signs, tips for caregivers on how to talk with adolescents about their mental health and well-being, and where families can turn to for additional support. Districts are encouraged to share this flyer with their community so families can access the recording of *Protecting Our Youth: A Community Approach to Suicide Prevention* as well as the other events in the series. As a reminder, please also note the following:

- Connecticut General Statues (C.G.S.) Section 10-221(e) requires each local and regional board of education to adopt a written policy and procedures for addressing youth suicide prevention.
- C.G.S. Section 10-220a requires each local or regional board of education to provide an annual in-service training program for its teachers, administrators and pupil personnel including information on the incidence of youth suicide, methods of identifying youths at risk of suicide and developmentally appropriate strategies for effective interventions to prevent youth suicide.
- C.G.S Section 10-222x requires each local and regional board of education to include the 988 National Suicide Prevention and Crisis Lifeline information on all identification cards distributed to students in grades 6-12.
- C.G.S. Section 10-212n requires the CSDE to provide each local and regional board of education with a list of the recommended assessments for determining the suicide risk of students. Jointly with the Connecticut Suicide Advisory Board, chaired by DCF and DMHAS, CSDE recommends that the Columbia-Suicide Severity Rating Scale (C-SSRS) be used as the assessment tool for determining the suicide risk of students.
