SUBJECT: Announcement of Unpaid Experiential Learning Program Continuation

The Connecticut State Department of Education (CSDE), in collaboration with the Connecticut Department of Labor (CT-DOL) is continuing the Unpaid Experiential Learning Program (UELP) for the 2025–2026 school year.

The purpose of the UELP is to enable local education agencies (LEAs), individual high schools, and their business and industry partners to place students in unpaid work-based learning opportunities for up to 120 hours per year. The approved UELP application is a waiver that supports LEAs' efforts to expand and build new pathways for students, while allowing for career skill development in an authentic setting.

UELP Briefing Sessions

The CSDE hosts four (4) virtual UELP briefing sessions to cover program overview, application procedures, partnership development, administrative requirements and compliance obligations. To participate in the UELP, one representative or a designee from your LEA must attend one (1) of the four (4) available briefing sessions.
