I. Welcome and Introductions

Participants were welcomed by Lieutenant Governor Nancy Wyman, and Commissioner of Education, Dianna R. Wentzell.

II. Acceptance of Meeting Minutes from April 5, 2018.

Minutes were unanimously approved.

III. Full, Equal and Equitable Partnerships with Families

Connecticut's Definition and Framework for Family Engagement

Presented by: Charlene Russell-Tucker, Chief Operating Officer, CSDE; Judy Carson, Education Consultant, CSDE; and Jennifer Johnson, Director, OEC

The presentation provided an overview of Connecticut's new definition and framework for family engagement. This work has been a collaboration of the Connecticut Early Childhood Funder Collaborative, the Office of Early Childhood and the Connecticut State Department of Education. The objective was to co-create a common vision, definition and approach to family engagement for all agencies working on behalf of children and families. The result is a definition that has clear consensus from representative groups, including families. The following is the resulting definition:

Family engagement is a full, equal, and equitable partnership among families, educators and community partners to promote children's learning and development from birth through college and career.

The meaning and importance of the words full, equal, and equitable were discussed. This was followed by a review of the guiding principles and an overview of the shift from low to high-impact practices. Members were asked to consider, "what can you do to support high-impact school-family partnerships?"

IV. Agency Dialogue on Developing Full, Equal, and Equitable Partnerships with Families

Charlene Russell-Tucker led a discussion with members on how the new definition and framework can be tailored to enhance other agencies' work. Ideas that were shared included:

- higher education has had a significant change in how new teachers are prepared for partnering with families;
- pre-K programs teach parents what it means to be engaged parents when students are school age;
- parent leaders are ambassadors of this work they are the critical messengers;
 and
- communities of faith and community agencies are important partners in the role out and implementation of family engagement partnerships.

It was learned at a recent national conference that many states are just getting started in this work.

V. CSDE Update

Charlene Russell-Tucker provided an update on the CSDE initiatives:

- 1. **Project AWARE** CSDE, in partnership with DCF, has received a five-year mental health grant from SAMHSA. The three objectives of the grant are to: 1) create awareness; 2) provide training; and 3) connect to service providers. The work will be focused in three school districts/communities: 1) Middletown; 2) Naugatuck; and 3) Windham.
- 2. **Connecticut School Discipline Collaborative** CSDE is convening a cross-sector group of stakeholders, including data analysts, child behavior specialists, lawyers and out-of-state experts to address issues in the area of exclusionary discipline. The first meeting will convene on October 31, 2018.
- 3. **Trauma-informed Practices** Understanding the impact of trauma on child development and student learning is the theme of an upcoming Alliance District Symposium.
- 4. **Chronic Absence** Recently, the CSDE released the 2017-18 chronic absence rates on its data portal, <u>EdSight</u>. The state, as a whole, has seen a slight uptick from 9.9 to 10.7 percent of students that were chronically absent. The causes of this increase and strategies for addressing it in the new school year were discussed.
