III. Out of Balance, Subsidized Housing, Segregation and Opportunity in Connecticut Report

Members of the Interagency Council engaged in a dialogue involving the historical context of housing in Connecticut, recent improvements in opportunities for education in low-income communities and the importance of this opportunity to embrace inclusionary zoning regulations.

IV. Juvenile Justice Policy & Oversight Committee (JJPOC) Update

Ms. Nowakowski provided an overview of the history and purpose of the JJPOC. It was created in 2014 by Public Act 14-217 and is charged with evaluating policies related to the juvenile justice system and the expansion of juvenile jurisdiction to include persons 16 and 17 years of age. The three strategic goals to guide juvenile justice reform efforts are:

- Increase diversion of children and youth from juvenile court by 20 percent;
- Decrease the number of children and youth confined (incarcerated) in state-run facilities by 30 percent; and
- Decrease the rate of recidivism among juvenile offenders by 10 percent.

JJPOC Work Groups have been established to identify ways to implement the three strategic goals. John Frassinelli and Erica Bromley, co-chairs of the Diversion Workgroup, provided the council members with a summary of the focus and activities of the workgroup. They provided more detail on the Community-based Diversion System adopted by the JJPOC and other activities related to truancy and school-based diversion.
