## **MINUTES**

- 1. Welcome and introductions
- 2. Review, amend and approve MSLC/MIC3 minutes from the November 2024 meeting. Motion to approve the minutes by Bob Ross was seconded by Susan Austin. The minutes from the November meeting were approved by a unanimous vote. MSLC meeting minutes from January 30, 2025 were also approved with one correction.
- 3. Update on **2024 MIC3 ABM**: Next ABM is in Indianapolis at the NCAA complex. Information will be posted on the MIC3 website in August. If interested in attending, reach out to Laura.
- 4. **MIC3 Training Schedule**: Upcoming schedule attached; training can be offered in-person or virtual. Coast Guard hosted a virtual training for 6 families this past January.
- 5. MIC3 Annual Report: quickly reviewed the annual report. The most contended topics that MIC3 supports are placement and attendance and graduation requirements.
- 6. **MIC3 Legal Advisory discussion**: Flexibility and Waiver of Graduation Requirements The MIC3 General Counsel, upon request of the California Commissioner has issued a legal advisory concerning the awarding of credits and graduation requirements under the Compact. This advisory results from several cases where military children were denied credit for courses previously taken in another state. Although the Compact states that school shall award credit, indicating that the schools must do this; the Compact further states "... if the coursework is similar to coursework in the previous state." This provision has created some confusion at the district level.
- 7. **House Bill 7123 discussion:** This bill proposes a change to the special education statutes, providing that military students with IEPs shall be reevaluated within 30 days of enrollment. The Commissioner testified against this bill and is currently working with the Veterans' Affairs Committee to draft language to require that the IEP be reviewed and implemented within 30 days of attendance. Members noted that in Connecticut, such implementation is already taking place for all students transferring into the districts. The Commission is also suggesting that the proposed changes to Section 10-186 be amended to clarify the specific rights of military children with a separate subsection. With respect to the provision

concerning the right to remain in school through the end of the school year, the districts generally allow this if the servicemember receives orders within a specified time period before the end of the school year. Captain Curtin noted that the phrase "and any other documents from the armed forces indicated a change of residency from such town during the school year..." was problematic. There are documents that will reference a new address when service members choose to move for personal reasons rather than professional.

Bob Ross noted that the DSLO Office of the Department of Defense, which initiated this provision, is currently being scrutinized for possible elimination.

## 8. State Council concerns, issues, other items

- A. Will need to seek a replacement on the council for Ms. Holy Cheeseman
- B. Fitch High School has changed their process and will now grant a half credit with grade on the transcript for yearlong classes. This is a great benefit for military families moving mid-year, but also provides an opportunity for students who struggled in the beginning to still gain credit during the year.
- C. Mentioned Pennsylvania case where a high school would not calculate a GPA for a transfer student impacting the student's ability to apply for scholarships/colleges as they required a GPA.
- Gregory Kane from Central Connecticut State University gave a presentation on Seaperch and Drone program. Both programs has competitions that schools/programs can get involved in. They offer teacher workshops to train teachers how to support their program at their locations.
