Temporary Adjustments Authorized Under the Keep Kids Fed Act of 2022

CACFP institutions face continued challenges related to the COVID-19 pandemic. To help alleviate some of those challenges, Section 3 of the Keep Kids Fed Act of 2022 (P.L. 117-158) provides temporary additional funding in the amount of 10 cents for each CACFP meal and supplement served. This additional reimbursement is available beginning July 1, 2022, and ends on June 30, 2023.

Additionally, the Keep Kids Fed Act of 2022 (P.L. 117-158) authorized a temporary measure to provide tier II homes with tier I reimbursement rates only for the period beginning July 1, 2022, and ending on June 30, 2023.

The chart on page 1 illustrates the national average payment factors and food service payment rates for meals and snacks in effect for the school year beginning July 1, 2022, and ending June 30, 2022, and **includes** the additional reimbursement authorized by the Keep Kids Fed Act of 2022 (P.L. 117-158) as described above.
